

**VIRGINIA:**

**BEFORE THE BOARD OF MEDICINE**

**ORDER**

In accordance with Sections 54.1-2919 and 9-6.14:11 of the Code of Virginia (1950), as amended ("Code"), an informal conference was held with Mi Yong Kim, M.D., on May 4, 2000, in Fredericksburg, Virginia. Members of the Virginia Board of Medicine ("Board") serving on the Informal Conference Committee ("Committee") were: Connell J. Trimber, M.D., Chairman; and Robert J. Bettini, M.D. Dr. Kim appeared personally and was represented by legal counsel, Claire Pettrone, Esquire. The purpose of the informal conference was to review Dr. Kim's compliance with the terms and conditions of indefinite probation imposed upon her license to practice medicine in Virginia by Order of the Board entered March 8, 1999 (Order"), as set forth in a Notice of Informal Conference dated April 7, 2000.

**FINDINGS OF FACT**

Now, having properly considered the information and statements presented, the Committee makes the following Findings of Fact:

1. By Order of the Board entered March 8, 1999 ("Order"), Dr. Kim's license to practice medicine was placed on indefinite probation on terms and conditions.
2. Pursuant to Term #1 of the Order, a Medical Practices Audit Committee ("MPAC") audited Dr. Kim's practice on November 5, 1999. The MPAC reviewed one hundred charts of patients who had pregnancy terminations, and forty charts of gynecological patients. The MPAC found the revised pregnancy termination charts to be "exemplary" and complete. It found the notes on the forty gynecological patients, although brief, adequate for the level of care rendered. It found Dr. Kim's practice clean, neat, well equipped and appropriately staffed for the services she is rendering.
3. Pursuant to Term #2 of the Order, Dr. Kim reported three referrals.
4. Pursuant to Term #3 of the Order, Dr. Kim provided a list of her staff with their licensure status

and qualifications, and a copy of her office protocols and consent forms. By letter dated June 22, 1999, Dr. Kim was notified that the Board approved this information.

5. Dr. Kim is in compliance with the terms and conditions of the Order.

**CONCLUSIONS OF LAW**


Based on the foregoing Findings of Fact, the Committee concludes that Dr. Kim is properly before it, and it is responsible for reviewing and approving all information relative to the terms of the Board's Order.

**ORDER**

WHEREFORE, based on the foregoing Findings of Fact and Conclusions of Law, it is hereby ORDERED that the terms and conditions imposed upon the license of Mi Yong Kim, M.D., be TERMINATED, and her license be REINSTATED to a full and unrestricted status with all attendant rights and privileges.

Pursuant to Section 9-6.14:14 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
