My elder son, Scott, recently graduated from Bowling Green State University in education and just passed the test to receive a teaching certificate. My younger son, Chris, who returned from the Peace Corps last year, was married in May. He then moved to Arizona where he will be teaching on an Indian reservation while earning a masters degree. My elder daughter, Tracy, will be attending Prescott College in Prescott, AZ, continuing her pursuit of Marine Biology. I continue to be sustained by the love and support of my family.

I request that my probation by the State Medical Board of Ohio be terminated. These last five years have been difficult in some ways, however very rewarding in others. Working with and serving the Native American population here in Phoenix has been a wonderful and satisfying experience.



Dr. Michaelis has continued in counseling consistently and has kept all scheduled appointments. He is always cooperative, pleasant and motivated to achieve his goals.




Dr. Michaelis has continued to be actively involved in the monthly counseling. He is highly motivated and is conscientious about keeping all his scheduled appointments.

Dr. Michaelis continues to experience significant financial stress in attempting to meet the on-going needs of his family, but maintains a constructive attitude to cope with the situation.


Dr. Michaelis has not exhibited any noticeable regression either behaviorally or emotionally as he has been functioning appropriately at all levels.

Arizona has refused to supervise my probation. They claim that their department is already working at capacity and they do not wish to take on the additional work of supervising new misdemeanors from out-of-state. Therefore, my lawyer and the Lucas County Adult Probation Department in Toledo, Ohio, are arranging for a retired federal probation officer to supervise me here in Phoenix.

I am under extreme financial stress at this time and I request that future appearances in Columbus be waved and that I be allowed to report by letter only. Thank you for your consideration.





As I indicated to you in a recent telephone call, I have relocated to Phoenix, Arizona, and am working for the Phoenix Indian Medical Center. At this time I am a temporary Civil Service employee but I have made application for a commission in the Indian Health Service. It is my intention to commit to at least two years in the I.H.S. and at the end of that time to make a decision re. a career in the I.H.S. vs. returning to private practice.

At the present time I have been allowed by the Sixth District Court of Appeals to relocate here temporarily in order that I might be employed. A hearing is set for April 7 to decide if I may continue to reside here permanently. I intend to comply with that decision and will notify you if my situation changes.

I continue to comply with all conditions of my probation. I have sought out a psychologist in this area for counselling. I am currently seeing him weekly. Enclosed is a copy of his Curriculum Vitae for approval by The Medical Board. I have signed a Release of Information form so that he can send you quarterly reports. I am reporting by phone and letter to Ms. Joyce William, my probation officer at the Lucas County Probation Board. If I am allowed to remain in residence in Phoenix, I will be transferring my probation supervision to a local office.

I request that I be allowed to report to you and The Medical Board by mail and by telephone while I am living here in Phoenix. It would be difficult to get leave to report in person as I am a new employee. Also, at least for the present, it would be a financial hardship. Nevertheless, if The Medical Board requests my personal appearance, I will certainly find a way to comply.

I also request that the Board determine that my period of probation should continue to run while I am outside of Ohio. As I indicated, I will continue with

psychological counselling and will continue to comply with all other conditions of my probation.

Dr. Thomas Michaelis has been a client of mine since December 4, 1991. He was Court ordered to participate in individual psychotherapy with me by the Honorable Ruth Ann Franks of the Lucas County Court of Common Pleas. In addition to individual therapy, Dr. Michaelis participates in a Sex Offender Group Therapy program which I supervise at the Lucas County Adult Probation Department. During the last quarter, Dr. Michaelis has regularly attended therapy sessions. He had one excused absence so that he could make site visit in Arizona with the Bureau of Indian Affairs where he was applying for employment. Dr. Michaelis is currently depressed about his financial and professional status. He is anxious to get back to work and not surprising his self esteem has suffered with the inability to be employed. He is working on the issues which brought him before the Court in both the Sex Offender group and the individual sessions.
