MINUTES

CALL TO ORDER

Eben Alexander, Jr., M.D., President of the Board of Medical Examiners of the State of North Carolina, called this meeting to order at 8:30 p.m., December 2, 1987, at the Sheraton Imperial Hotel, Research Triangle Park, North Carolina.

The Board members present at this meeting included: John Thomas Daniel, Jr., M.D.; Charles Howard Duckett, M.D.; Harold L. Godwin, M.D.; Hector Himel Henry, II, M.D.; F. M. Simmons Patterson, M.D.; Nicholas Emanuel Stratas, M.D.; and Mrs. Kathryn Howell Willis.

Staff members present included: Bryant D. Paris, Jr.; Don Pittman; William H. Breeze, Jr.; Robert J. Broyles; L. D. Beaver; Kathy Burke; and Sibyl Lamoreaux.

GROSSMAN, Jon Edward, M.D., Chapel Hill, North Carolina

On December 3, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Patterson and seconded by Dr. Godwin: (1) that the Board not renew Dr. Grossman's dated, limited license; (2) that, if Dr. Grossman wishes to resume the practice of medicine in North Carolina, he must appear before the Board of Medical Examiners of the State of North Carolina to apply for licensure; and (3) that, if Dr. Grossman requests further licensure in this state, he must furnish the Board with:

a report from someone involved in his treatment program in Georgia,

a report from the Chairman of the Anesthesiology Department at North Carolina Memorial Hospital, and

a current report from the psychiatrist conducting Dr. Grossman's therapy.

LICENSURE STATUS REPORT

The President of the Board instructed that the staff provide copies of all formal orders issued by the Board of Medical Examiners to Deans of the North Carolina medical schools.

## IMPAIRED PHYSICIANS PROGRAM

On December 3, 1987, Henry Carr, M.D.; Ernest Spangler, M.D.; Mr. George Moore; and Mr. Alan McKenzie appeared to discuss this proposed program with the members of the Board of Medical Examiners.

The representatives from the North Carolina Medical Society agreed to work with the appointed representatives of the North Carolina Board of Medical Examiners in the development of a revised program to be presented for the consideration of all the members of the Board.

Dr. Alexander, the President of the Board of Medical Examiners, assured the representatives of the North Carolina Medical Society that the Board of Medical Examiners wishes to be as cooperative as possible in developing this program and appointed Harold L. Godwin, M.D., and Charles H. Duckett, M.D., to be the Board's representatives to work with the Medical Society in developing plans for a Physicians Health and Effectiveness Committee.

LEE, Tong Hoon, M.D., Spring Lake, North Carolina

On December 3, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Patterson that the Board offer Dr. Lee the opportunity to enter into a Consent Order agreeing:

1. to take SPEX in March, 1988, with unrestricted licensure being dependent upon results;
2. to surrender DEA prescribing privileges in Schedules 2, 2N, 3, and 3N;
3. to furnish evidence of completion of fifty hours of Category I, AMA or Family Practice approved, Continuing Medical Education with clinical relevance; and
4. to appear for an interview when the Board receives his examination results and at such other times

RITCHIE, Henry Jackson, M.D., Concord, North Carolina

On December 3, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Duckett that the Board offer Dr. Ritchie the opportunity to enter into



a Consent Order stipulating that:

1. Dr. Ritchie will surrender his DEA prescribing privileges in Schedules 2N, 3N, and 4;
2. Dr. Ritchie will agree to such monitoring of his prescribing practice and patient records as the Board deems necessary;
3. Dr. Ritchie will improve his record-keeping procedures by instituting a dictation system or by entering handwritten notes in patient records documenting: examinations, histories, treatment rendered, and medical indications for the drugs prescribed; and, finally,
4. Dr. Ritchie will appear for interviews at such times and places as the Board may direct.

SMITH, Amaziah Parker, M.D., Goldsboro, North Carolina

On December 3, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Patterson and seconded by Dr. Stratas that the Board offer Dr. Smith the opportunity to enter into a Consent Order containing the following stipulations.

1. Dr. Smith will surrender his DEA prescribing privileges in Schedules 2, 2N, 3, 3N, and 4;
2. Dr. Smith will take SPEX in March, 1988, with the knowledge that the Board will base future actions on the the results of this examination;
3. Dr. Smith will improve his record-keeping by documenting treatment rendered and medical indications for all drugs he prescribes; and
4. Dr. Smith will agree to such monitoring of patient records as the Board deems necessary;

ROSE, Selwyn, M.D., Winston-Salem, North Carolina

On December 3, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Stratas that the Board offer Dr. Rose the opportunity to enter into a Consent Order with the Board of Medical Examiners on the basis of N.C.G.S. 90-14(a)(6) reprimanding Dr. Rose for providing patients with controlled substances, which he has admitted he

lacks an adequate knowledge base to administer, and containing the following stipulations:

1. Dr. Rose will surrender his DEA prescribing privileges in Schedules 2, 2N, 3, and 3N;
2. Dr. Rose will agree to the Board's monitoring randomly selected patient charts;
3. Dr. Rose will appear for another interview with members of the Board of Medical Examiners at the end of one year and will furnish evidence of participation in continuing medical education in the area of Psychosomatic Medicine; and
4. If future chart reviews warrant additional interviews, Dr. Rose will agree to appear at such times and places as the Board of Medical Examiners may direct.

STUELKE, Richard Gaylord, M.D., Durham, North Carolina

On December 3, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Duckett and seconded by Dr. Patterson: (1) that the Board extend Dr. Stuelke's dated license for one year; (2) that the Board instruct Dr. Stuelke to appear for an interview prior to the expiration of this dated license; and (3) that the Board advise Dr. Stuelke to provide a medical report from his personal physician prior to this informal interview.

CORRELL, Earl Eugene, M.D., Kannapolis, North Carolina

On December 3, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Patterson and seconded by Dr. Stratas that the Board offer Dr. Correll the opportunity to enter into a Consent Order stipulating that:

1. Dr. Correll will surrender his DEA prescribing privileges in Schedules 2, 2N, 3, and 3N;
2. Dr. Correll will agree to the Board's monitoring his patient charts to be selected at random;
3. Dr. Correll will appear for another interview with members of the Board of Medical Examiners at the end of one year; and, at this time, he will furnish evidence showing completion of fifty hours of

continuing medical education in an area other than Cabarras County.

CREED, Donald Wendell, M.D., Elizabethtown, North Carolina

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Duckett and seconded by Dr. Godwin that the Board offer Dr. Creed the opportunity to enter into a Consent Order containing the following stipulations:

1. Dr. Creed will surrender his DEA prescribing privileges in Schedules 2, 2N, 3, and 3N;
2. Dr. Creed will take SPEX in March, 1988, with the understanding that the Board will base future actions on the results of this examination;
3. Dr. Creed will improve his record-keeping in terms of both legibility and content;
4. Dr. Creed will agree to the Board's monitoring randomly selected patient charts; and
5. Dr. Creed will appear for another interview with members of the Board of Medical Examiners at the end of six months.

COFFMAN, Donald Ralph, M.D., Greensboro, North Carolina

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Henry that the Board offer Dr. Coffman the opportunity to enter into a Consent Order containing the following stipulations:

1. Dr. Coffman will surrender his DEA prescribing privileges in Schedules 2, 2N, 3, 3N, and 4;
2. Dr. Coffman will consult an Internist, approved by the Board of Medical Examiners;
3. Dr. Coffman will request the Internist to perform a complete physical examination, to include liver function studies and organicity;
4. Dr. Coffman will also request the Internist for a psychiatric referral;
5. Dr. Coffman will obtain a complete Psychiatric

evaluation;

6. If the Psychiatrist deems further testing by a Psychologist to be advisable, Dr. Coffman will comply with this recommendation;
7. Dr. Coffman will furnish the results of these evaluations to the Board of Medical Examiners by the end of February, 1988;
8. Dr. Coffman will provide the Board with random urine samples for drug screening; and
9. Dr. Coffman will appear for an interview with the Board of Medical Examiners at its March, 1988, meeting.

The Board agreed that it would approve Howard Scheyer Wainer, M.D., Greensboro, North Carolina, as an Internist to evaluate Dr. Coffman's physical condition.

On December 4, 1987, the Board of Medical Examiners adopted a motion made by Dr. Duckett and seconded by Alexander, with five affirmative and three negative votes: (1) that the Board amend its previous motion to reaffirm all of the stipulations in the proposed Consent Order except for the one stating: "Dr. Coffman will surrender his DEA prescribing privileges in Schedules 2, 2N, 3, 3N, and 4"; (2) that the Board modify this stipulation as follows: "Dr. Coffman will voluntary agree not to prescribe any controlled substances in Schedules 2, 2N, 3, 3N, and 4."; and (3) that the Board add the following stipulation: "If Dr. Coffman fails to comply with any of the conditions in this Consent Order, he will immediately surrender his license to practice medicine in the state of North Carolina."

CAMP, Edmond Weyman, III, M.D., Louisiana

On December 4, 1987, the Board of Medical Examiners of the State of North Carolina held a hearing on charges preferred on the basis of N.C.G.S. 90-14(a)(5) and (13) against Edmond Weyman Camp, III, M.D. Neither Dr. Camp nor his counsel appeared at this hearing. Pursuant to N.C.G.S. 90-14.7., the President of the Board of Medical Examiners called this hearing to order.

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Duckett and seconded by Dr. Henry that the Board finds the charges preferred against Edmond

Weyman Camp, III, M.D., to be true. On December 4, 1987, the Board of Medical Examiners unanimously adopted a further motion made by Dr. Godwin and seconded by Dr. Patterson that the Board revoke the license to practice medicine in the state of North Carolina previously issued to Edmond Weyman Camp, III, M.D., until such time as he has proven his ability to practice medicine with reasonable skill and safety to patients by satisfactorily completing the usual medical licensure process in this state.

LYNCH, Clifford James, M.D., Springfield, Illinois

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Duckett: (1) that the Board of Medical Examiners of the State of North Carolina offer Dr. Lynch the opportunity to enter into a Consent Order based on the probationary conditions imposed on Dr. Lynch's medical licensure in the state of Illinois; (2) that the Board not include in its Consent Order the Illinois Board's condition which stipulates Dr. Lynch will surrender his medical license certification to be marked "Probation"; but (3) that the North Carolina Board of Medical Examiners add a stipulation to the probationary conditions imposed by the Illinois Board specifying, if Dr. Lynch wishes to engage in the practice of medicine in North Carolina, he must notify the Board of Medical Examiners prior to engaging in such medical practice, in order that the Board can schedule an interview with Dr. Lynch.

MELMED, John Richard, M.D., Potomac, Maryland

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Henry and seconded by Dr. Patterson that the Board offer Dr. Melmed the opportunity to enter into a Consent Order based on the action taken by the Maryland Board.

SMITH, Joseph Arthur, M.D., Fort Washington, Pennsylvania

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Stratas and seconded by Dr. Duckett that the Board prefer charges against Joseph Arthur Smith, M.D., based on N.C.G.S. 90-14(a)(1) and (6); and that, if Dr. Smith will voluntarily surrender his license to practice in the state of North Carolina, the Board will accept this voluntary licensure surrender in lieu of preferring charges

against him.

#### QUESTIONS FOR APPLICANTS

The President requested the staff to provide Board members with copies of the questions presently asked all applicants for licensure so that the Board members may compare the present questions with the suggested revisions.

LAIRD, John Lindsay, M.D., Leicester, North Carolina

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Alexander and seconded by Dr. Duckett that the Board write the following letter to Dr. Laird:

At its December, 1987, meeting, the Board of Medical Examiners of the State of North Carolina reviewed reports indicating that you are pursuing the practice of chelation therapy outside the confines of your clinic.

It is the position of the Board of Medical Examiners that physicians should administer chelation therapy only when this treatment is part of a research protocol. Moreover, the Board understands there are physicians in Massachusetts utilizing an approved research protocol and conducting this type of therapy.

Should you have additional questions about the Board of Medical Examiners' position on the use of chelation therapy, please advise.

#### LINCOLN COUNTY HEALTH DEPARTMENT

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Duckett and seconded by Dr. Daniel: (1) that the Board instruct the Executive Secretary and the Attorney for the Board to respond to Dr. Smith's letter.

MC ELROY, Richard Allen, M.D., Landis, North Carolina

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Alexander and seconded by Dr. Daniel that the Board accepts the Consent Order modifications to conditions 2, 3, and 4 proposed by Dr. McElroy's attorney; but that the Board stipulates condition 1 in this Consent Order

read as follows: "Dr. McElroy agrees not to use Vitamin B-12 by injection in weight control cases and also agrees not to use anorectics, including Fastin, in weight control cases unless such usage complies with the provisions set forth in the Board of Medical Examiners' Statement on Use of Anorectics.

DUFFY, Eileen Teresa, M.D., Morganton, North Carolina

On December 4, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Henry that the Board respond to Dr. Duffy's request for full, unrestricted medical licensure in the state of North Carolina as follows:

At its December, 1987, meeting, the Board of Medical Examiners of the State of North Carolina considered your request for a full and unrestricted license to practice medicine in this state.

As a result of this consideration, the Board advises North Carolina General Statutes require a physician to complete three years of postgraduate training and education, approved by the Accreditation Council for Graduate Medical Education, in order to be eligible for full medical licensure in this state.

Although you indicate you have met the standards for eligibility set forth by the American Board of Psychiatry and Neurology, these standards do not meet the statutory requirements for full and unrestricted medical licensure in the state of North Carolina. Therefore, the Board of Medical Examiners must deny your request for a full license; however, the Board has approved the extension of your dated, limited license for a period of two years.

If you wish medical licensure in this state after December 15, 1989, please notify the Board prior to the expiration of the enclosed license.

NEWELL, Frank Donald, M.D., Hendersonville, North Carolina

On December 5, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Alexander and seconded by Dr. Daniel that the Board deny approval of this physician's license application.

BREMER, Martin Lamar, D.O., Demorest, Georgia

On December 5, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Alexander and seconded by Dr. Daniel that the Board deny approval of this physician's license application.

LIPSEY, John Crawford, M.D., Blacksburg, Virginia

On December 5, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Alexander and seconded by Dr. Daniel to:

1. Issue Dr. Lipsey a dated license for a period of one year limited to the practice of medicine at Fellowship Hall, Greensboro, North Carolina;
2. Obtain an agreement from Dr. Lipsey that he will comply with the following recommendations:
  - a. join a physicians support group in Greensboro,
  - b. attend AA and/or NA meetings regularly,
  - c. place himself under the care of a primary physician,
  - d. submit urine samples for random drug screens, and
  - e. appear for another interview prior to the expiration of this dated, limited license.

The Board instructed its attorney to prepare a letter of agreement to accompany Dr. Lipsey's temporally and geographically limited license.

LOU, Emory Tien-Sze, M.D., East Setauket, New York

On December 5, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Patterson and seconded by Dr. Henry that the Board request Dr. Lou to provide additional information from Drs. Cooley, DeBakey, and Thompson certifying that Dr. Lou's training in their combined programs is equivalent to a three year residency training program; and that, upon receipt of this additional information, the Board advise it will reconsider Dr. Lou's application for licensure.

FRANZ, Karl Herman, M.D., Chapel Hill, North Carolina

On December 5, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Henry and seconded by Dr. Godwin that the Board deny approval of Dr. Franz's application for a license to practice in the state of North Carolina.



LUDINGTON, Laurie Churchill, M.D., Lumberton, North Carolina

On December 5, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Henry that the Board extend Dr. Ludington's dated license for a period of two years; and that the Board of Medical Examiners interview her again at the end of one year.

Dr. Alexander told Dr. Ludington, "The Board members appreciate your coming today, congratulate you, and in some way ourselves, on your progress. The Board of Medical Examiners will extend your dated license for a period of two years and will schedule another interview with you at the end of one year."

BLACK, William John, M.D., Johnson City, Tennessee

On December 5, 1987, the Board of Medical Examiners unanimously adopted a motion made by Dr. Alexander and seconded by Dr. Daniel that the Board approve this physician for licensure if and when he provides the Board with a certified photograph from the Director of his Residency Program at East Tennessee State University.

OBEBE, Joseph Olusegun, D.O.
