Comprehensive sexual health education law

Starting on January 1, 2014, Illinois began to require that sexual health education offered in schools must be age-appropriate, medically accurate, and complete. To support the implementation of this law, PPIL initiated curriculum review, teacher training, parent workshops, and support for classroom teaching to empower thousands of teachers, parents and students with information and knowledge.

Contraception now

In October, 2014, a policy statement and technical report issued by the American Academy of Pediatrics recommended long acting reversible contraception (LARCs), which include intrauterine devices and subdural implants, as the first line contraceptive choice for teens. LARCs are also recommended by the American College of Obstetrics and Gynecology. PPIL is one of the few Illinois providers to stock all forms of birth control including LARCs on site at all locations.

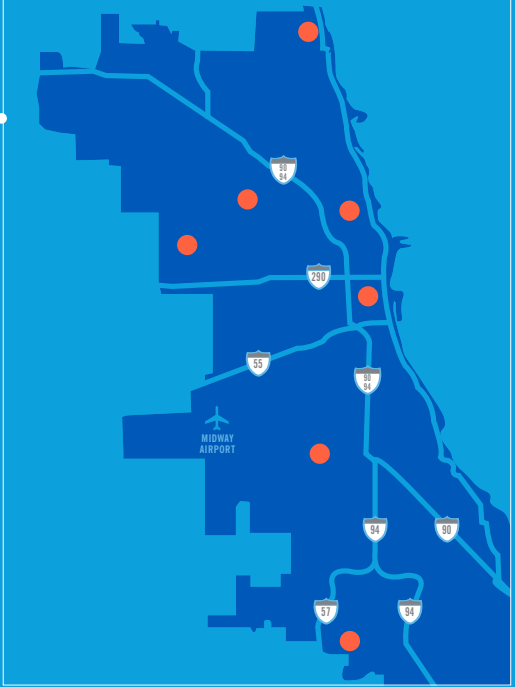
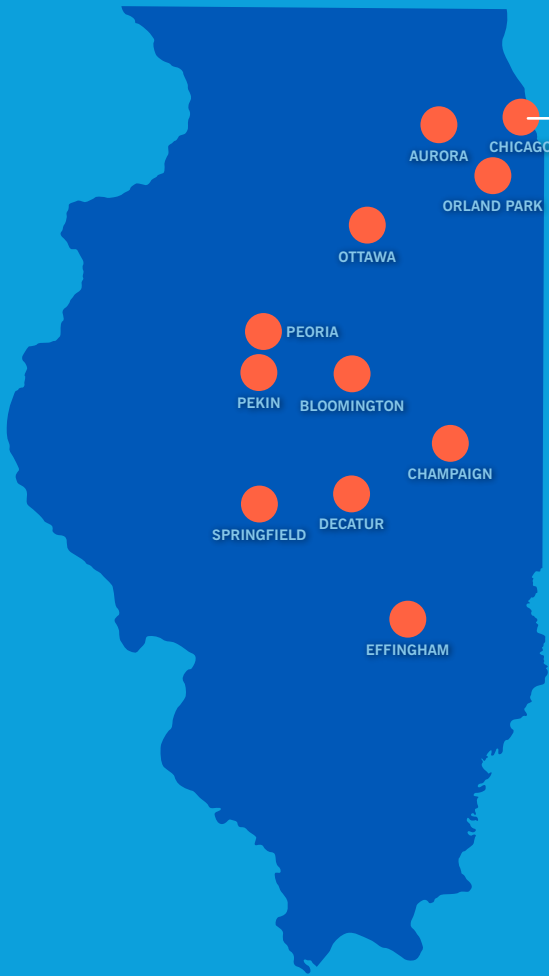
