Hello Cheryl Sullenger,

Based on South Wind's pattern from previous years, the last 2017 KCFL Scheduled shift will be on **December 22<sup>nd</sup> at 5:00 pm** and the first 2018 Scheduled Shift will be on Wednesday, **January 3<sup>rd</sup> at 7:15 am.**

An extremely important incident occurred on Monday afternoon, December 18<sup>th</sup> at the South Wind abortion facility, when a young woman who had undergone a botched chemical abortion, most likely on twins, came back in to South Wind for follow-up care. When one baby came out, South Wind had made the likely incorrect assumption that the abortion was complete.

She was suffering a fever of up to 107 degrees, and was in urgent need of immediate emergency medical care, but lacked the funds to go to the Emergency Room.

Instead of caring for her, **Abortionist Leslie Page D.O.** sent her to ask for help at the KCFL table. The girl politely asked us for money to go to the emergency room, and explained her condition. I said that we would help her, but that normally people accept our help prior to the abortion, not after.

The girl said that she did not have an abortion, but that she had come to South Wind to get a miscarriage. She said that she would never have signed for an abortion, and was told that it was going to be a miscarriage only, which she signed for.

We directed her back again to the ProLife Choices Medical Clinic, but she had already been there, and they had sent her back to South Wind in the first place.

That is why as a last resort, KCFL was being asked to pay for her botched abortion emergency care, and we did not decline.

I called Choices Medical Clinic, and she was in, this time to be taken to Saint Joseph Hospital.

(More on this incident when more facts are known.)

We may need new legislation to stop South Wind from sending their botched abortion clients to the proLife community for charity care. This is not the first time this kind of thing has happened.
