L.A. City Council Hearing on Enforcement of AB 775 Reproductive FACT Act



Dr. Angela Chen joined NARAL, physicians, scientists, and religious leaders to show their support of the LA City Council and the LA Attorney General in holding CPCs accountable for their false advertising. The Reproductive Freedom, Accountability, Comprehensive Care, and Transparency Act AB 775 requires licensed facilities that provide pregnancy-related services to notify clients that the state offers access to low-cost and free abortions. It requires unlicensed facilities to disclose that they're not licensed by the state to provide medical care. At the hearing, undercover journalist Megan Koester talked about her experience at a CPC. Our FP providers have special expertise in localization and removal of the non-palpable implant. Patients who are unable to have their implant retrieved at outside facilities will be referred to the clinic for higher level of care in complex implant removals.
