ANSWER TO ORDER TO SHOW CAUSE

Rose Health Services Company, by and through its attorney, Julia E. Gabis, Esquire, hereby files an Answer to the Order to Show Cause in the above-captioned matter and, in support, avers as follows:

- 1. Denied as a conclusion of law to which no response is required.
- 2. Denied as a conclusion of law to which no response is required.

the "board eligible" requirement is Vikram Kaji, M.D., F.A.C.O.G. ("Dr. Kaji"). Dr. Kaji is a board-certified obstetrician-gynecologist, with a Pennsylvania medical license MD031218L. Verification of Dr. Kaji's license and board status is attached hereto as Exhibit "A."

- 9. Denied. This allegation is specifically denied. Richard Efrem Gordon, M.D. ("Dr. Gordon"), saw patients through January 28, 2012 in the offices of Allentown Medical Services. By way of further answer, even if Dr. Gordon had resigned, Rose Health Services Company met its obligation to have a physician on staff or as a consultant who meets the "board eligible" requirements under 28 Pa. Code \$29.33(4) through Dr. Kaji.
- 10. Denied. This allegation is specifically denied. As of Monday,

 January 9, 2012 (and at all relevant times), Dr. Kaji has been available for new patients
 either as a staff member or as a consultant at Allentown Medical Services as required
 by 28 Pa. Code §29.33(4).
- 11. Denied. This allegation is specifically denied. Dr. Kaji has been available at all relevant times for new patients either as a staff member or as a consultant at Allentown Medical Services as required by 28 Pa. Code §29.33(4).
- 12. Denied. This allegation is specifically denied. Dr. Kaji has been available at American Women's Services for new patients either as a staff member or as a consultant at all times as required by 28 Pa. Code §29.33(4).
- 13. Neither admitted nor denied. The regulation is a writing and speaks for itself.

- 21. Denied. This allegation is specifically denied. Dr. Kaji is the "board eligible" physician made available for new patients either as a staff member or as a consultant for Allentown Medical Services. Allentown Medical Services meets the "board eligible" requirement of the ACA regulations.

- 22. Denied as a conclusion of law to which no response is required. By way of further answer, the failure of an abortion facility to meet the "board eligible" requirement does not constitute an "infrastructure failure" under the MCARE Act.
- Officer for Rose Health Services Company advised the Department that Dr. Gordon was continuing to see patients after January 11, 2012. Dr. Gordon did, in fact, see patients after that date. By way of further answer, although the Department affirmatively sought confirmation of Dr. Gordon's resignation from a representative of Rose Health Services Company, the Department failed to inquire or investigate whether Allentown Medical Services had a physician who met the "board eligible" requirement of the ACA regulations. Had the Department inquired or conducted an adequate investigation before filing the instant Oder to Show Cause, Rose Health Services Company would have informed the Department that Dr. Kaji serves as the "board eligible" physician for Allentown Medical Services and meets the "board eligible" requirement of the ACA regulations.
- 24. Denied. This allegation is specifically denied. Allentown Medical Services did not have an infrastructure failure and had no obligation to report Dr. Gordon's resignation to the Department.
- 25. Denied. This allegation is specifically denied. American Women's Services did not have an infrastructure failure and, thus, had no obligation to report Dr. Gordon's resignation to the Department.

- 26. Denied. This allegation is specifically denied. Dr. Gordon's resignation is irrelevant to American Women's Services' obligation under the ACA regulations. Dr. Kaji, a "board eligible" physician made available either as a staff member or as a consultant, fully meets the requirements of the "board eligible" requirement of the ACA regulations.
- Officer for Rose Health Services Company advised the Department that Dr. Gordon was continuing to see patients after January 11, 2012 and, in fact, Dr. Gordon did see patients after that date. By way of further answer, although the Department affirmatively sought confirmation of Dr. Gordon's resignation from a representative of Rose Health Services Company, it failed to inquire or investigate whether American Women's Services met the "board eligible" requirement of the ACA regulations. Had the Department inquired or conducted an adequate investigation before the filing the Order to Show Cause, American Women's Services would have informed the Department that Dr. Kaji serves as the "board eligible" physician and meets the "board eligible" requirement of the ACA regulations.
- 28. Denied as a conclusion of law. By way of further answer, the failure of an abortion facility to meet the "board eligible" requirement does not constitute an "infrastructure failure" under the MCARE Act.
- 29. Denied. This allegation is specifically denied. American Women's Services did not have an infrastructure failure and, thus, had no obligation to report to the Department.


