RECORDED SYNOPSIS TEXT

On 10/29/2010 I spoke on the phone to Jennifer St Claire in regards to a complaint she had of a doctor performing abortions at the Red River Women's Clinic with an expired ND State Medical License. St Claire said she had discovered through contact with the ND State Board of Medical Examiners that was employed at the Red River Women's Clinic and that her license to practice in North Dakota had expired on 6/30/2010.

I then went to Red River Women's Clinic and spoke clinic manager Tammi Kromenaker. Kromenaker told me that the clinic and that as far as Kromenaker knew had a current license in North Dakota.

I then called the North Dakota State Board of Medical Examiners and spoke to Lynette McDonald. McDonald told me that license had expired on 6/30/2010 and they were already aware of the situation and they were starting an investigation there. McDonald told me she had spoken to and that told her she forgot to renew her license. McDonald told me had already started the process of renewing her license.

Kromenaker then called me back to say she checked their records and found license was expired and that been made aware of this.

Please forward this report to the ND States Attorney's Office for violation of the ND Century Code 14-02.1-04, Providing Abortion without a license.
