

On the morning of Oct. 7th several people from my church, including myself, were
outside, in front of Affiliated Medical Services (abortion clinic), holding signs, and praying
when one couple who had gone into the clinic at = 8 a.m. and left at = 10 a.m., return
At ~ 10:15 a.m., the male driver stopped his car in the middle of the road, the passenger-
side door opened, but no one came out. A pro-abortion clinic escort went over to the
car door and tried to pull the young woman out. We heard moans, and then he finally
lifted her out of the car into his arms and carried her into the clinic. She had her
eyes shut, was groaning loudly, and her pants were soaked with blood in the back
from just below her waist, down to the bottom of her buttocks. Something was
obviously very wrong, and a couple of people outside the clinic called 911 for help.
One call eventually went through and the Milw. Fire Dept. and Police Dept. responded.
A single police officer arrived and went into the clinic first, but the four firefighters
Who came a little later were stopped at the door, and not allowed to enter. An abortion
clinic morker (or escort?) pecked her head out the fover door, and was nodding and waving
her hand, like everything was O.K. After less than one minute of talking with her, the
fire fighters started getting back onto their truck. When asked if the woman was alright,
or if they could at least go into the clinic to check with clockor, or check with the woman
herself, they said "no, not if the clinic told them everything was O.K." They said
they were sorry, but their hands were tied. A week or so later, a person from church
Said they had gotten the license # of the car. It was a silver Dodge, #
I wasn't sure how to check up on that information, but may be your dept has the
authority to use it to investigate this incident, and see if she suffered any severe injuries.
Less than two months later, I was shocked to read about an incident that occurred
at Attiliated Medical Services-again. Enclosed is a copy of the article newsletter
describing the incident. A young woman was taken by ambulance from Affiliated Medical Services
to St. Mary's Hospital, so there was obviously some significant injury. The hospital and
(OVER)

fire dept. records from Nov. 28th should be available for you to verify.
Two significant incidents within less than two months sends up some
red flags. These are warning signs that something is not right there with the
level of health care, and needs to be investigated. Both Dr. Duncan and Dr. Smith
Work at Affiliated Medical Services. I'm not sure who is responsible. But, also of
significance is that Dr. Duncan does have a history of conviction for drug
posession and assault on his (ex)-wife. Enclosed is a copy of the Milw. Journal-
Sentinal article.
I didn't disclose my name or other information because the pro-abortion
escorts and clinic workers can sometimes be very intimidating and retaliatory in
nature. Your dept. secretary said this complaint form could be done anonymously
and it would still be worthwhile to have this report on file. Also, the Milw.
Health Dept. said to contact your dept. regarding these incidents.
Thank-you for your time and attention to these serious matters.

WOMAN HARMED BY "SAFE-LEGAL" ABORTION IS TAKEN TO MILWAUKEE HOSPITAL

On Tuesday, November 28th, a woman was taken from *Affiliated Medical Services* by ambulance to St. Mary's Hospital. Affiliated is one of two death camps where abortions are routinely performed here in Milwaukee.

Missionaries Jim Soderna and John Stambaugh were outside the death camp speaking up for the preborn and offering help to the moms, when at about 2:15 p.m., a Milwaukee Firefighter Paramedic ambulance approached with lights flashing and siren roaring. The paramedics entered the facility and emerged about 10 minutes later with a woman on the stretcher. The ambulance pulled around to the back door in the alley to remove the woman from the clinic.

Doctor sentenced to 30 days in jail

Gynecologist pleaded no contest to beating his wife, possession of crack cocaine

A gynecologist was placed on n months' probation, sentenced o 30 days in jail and fined \$250 Thursday, after pleading no conest to charges that he beat his ..ਪੋe and was arrested with crack cocaune in his pocket.

Neville W. Duncan was senenced by Circuit Judge Maxine Aldridge White after pleading no contest, to a county disorderly conduct citation and a state misdemeanor charge of possession of cocaine base.

Duncan, who performs abornons and has drawn attention as a target of anti-abortion prorests, was sentenced by White as a handful of protesters watched from the gallery.

"I'm not familiar with his practice, and I'm not going to delve into what he does as socior," White said.

However, White added; "When you are providing medcal services to others, they expect you to be healthy and in a good way.... In this case, I want him to be monitored. If he is to continue as a medical professional, he needs to remain abso-Jutely drug-free."

The sentencing came at a low point in the life of Duncan, a 57-year-old native of Jamai who persevered after his ents emigrated to the States and struggled to " living in Harlem.

A physician since 1973, Duncan came to Wisconsin hoping to establish a solid medical practice. However, he became controversial for his abortion work, and developed financial problems so severe that he fell the time; his wife was later fined

ments from a previous marriage and was threatened with eviction in Waukesha County after he and his wife fell behind on nearly \$1,000 in 1997 water bills.

Duncan currently is serving a 90-day civil contempt jail term in Waukesha County for the child support failures, his attorney, Craig Allbee, told Whiteon Thursday.

Duncan, who had been scheduled to stand trial Thursday, told White he was "ashamed" and "deeply sorry" for the inddents that led to his arrest Sept. 21 in the 3800 block of N. Port Washington Ave.

Duncan was arrested after allegedly punching his wife in his car, then pinning her to the ground and slapping her after she climbed out the window of the vehicle, according to the criminal complaint.

When he was arrested, according to the complaint, officers found small amounts of crack totaling 0.004 gram in his pocket


Albee told White on Thursday that Duncan faces possible disciplinary action by the state Medical Examining Board because of the case.

Assistant District Attorney Thomas J. McAdams, who recommended the sentence White eventually, imposed, told the judge that Duncan, because of his background and education, "should have and probably did k y better than to get inaved with crack.

Duncan's wife, Brenda, said in court that she did not want to see her husband go to Jail.

Brenda Duncan gained notoriety in January 1998 when she mooned and threatened a crowd of abortion protesters who demonstrated outside the couple's former New Berlin home.
