#### **FINAL ORDER**

Having reviewed the Notice of Intent to Impose Fine dated March 4, 2010, and all other matters of record, the Agency for Health Care Administration finds and concludes as follows:

#### FINDINGS OF FACT

- 1. On March 4, 2010, the Agency issued a Notice of Intent against the Respondent, BSS International Inc, an abortion clinic. The Notice of Intent is attached hereto and incorporated herein (Exhibit 1). The findings of fact and law set forth in Exhibit 1 are adopted.
- The Respondent was served the Notice of Intent on March 8, 2010, by
   U.S. Certified Mail, return receipt requested. (Exhibit 2)
- 3. Enclosed with the Notice of Intent was an Election of Rights form, which advised Respondent of its right to a hearing pursuant to Section 120.57(1) or 120.57(2),

Florida Statutes. The Respondent selected Option (1), admitting the allegations of fact and law contained in the Notice of Intent and expressly waiving the right to a hearing on the Election of Rights form (Exhibit 3)

#### **CONCLUSIONS OF LAW**

- 4. The Respondent is subject to the Agency's jurisdiction pursuant to the provisions of Florida Statutes.
- 5. The Agency may assess an administrative against the Respondent as stated in the Notice of Intent.

Based on the foregoing findings of fact and conclusions of law, it is

#### **ORDERED:**

- 1. An administrative fine of \$200 is hereby imposed upon the Respondent.

  The fine is now due and payable within 30 days, unless payment has already been made.
- 2. A check should be made payable to the "Agency for Health Care Administration." The check, along with a reference to this case number, should be sent directly to:

3. Unpaid fines will be subject to statutory interest and may be collected by all methods legally available.
