
On October 21, 2010, the Director and the Department granted a variance to the Lebanon Road Medical Building (Center) from the written hospital transfer agreement requirement of OAC 3701-83-19 (E).

Recently Dr. Haskell has expressed a desire to be less involved with the day to day activities of the Center and that he wishes to spend an increased amount of time traveling away from Cincinnati in the coming year. In view of this, we believe that it is in the best interests of the Center and its patients to make alternative arrangements for the hospital admission of patients should the need arise.

The Center has entered into backup agreements with David Schwartz, MD and Walter Bowers, MD (copies attached) to accept and care for patients that may need hospital admission. Both Dr. Schwartz and Dr. Bowers have unrestricted admitting privileges in OB-GYN at the Christ Hospital in Cincinnati. I wish to substitute Dr. Schwartz and Dr. Bowers as the physicians providing hospital admitting services in the variance granted to the Center. Our emergency protocol remains unchanged from the one presented with the original request for variance.





Dear Ms. Haskell:

This letter is in response to your August 31, 2011, letter in which you request that the variance issued by the Ohio Department of Health on October 21, 2010, to the transfer agreement requirement set forth in paragraph (E) of Ohio Administrative Code rule 3701-83-19 be modified to substitute the two physicians listed below for Martin Haskell, MD as physicians having admitting privileges at a Cincinnati Hospital and who will provide emergency back-up services and hospital admission for patients of the Lebanon Road Surgery Center.

David B. Schwartz, MD, unrestricted admitting privileges at The Christ Hospital, Cincinnati
Walter T. Bowers, II, MD, unrestricted admitting privileges at The Christ Hospital, Cincinnati

On September 8, 2011, my staff verified these admitting privileges with The Christ Hospital. Dr. Schwartz's privileges come up for renewal on May 31, 2013, and Dr. Bower's on September 30, 2012. It is my understanding that Roslyn Kade, MD will continue working at the facility and that her privileges at The Christ Hospital remain valid through February 28, 2012.

After reviewing your correspondence and evaluating the information contain therein, I find that the variance approved on October 21, 2010, continues to provide for the continuity of care and the timely and unimpeded acceptance and admission of the ASF's emergency patients at a Cincinnati area hospital. Lebanon Road Surgery Center's variance continues to be conditioned on: 1) the continued association of the Lebanon road Surgery Center with the three physicians named in this letter; 2) continuation of admitting privileges for each of the three physicians named; 3) the strict adherence to the Lebanon Road Surgery Center Emergency Protocol by all staff of the facility; and 4) the continued provision of timely and quality back-up emergency care by the physicians who provide services at the facility and those who provide back-up services and care as may be needed.

Should evidence of the reappointment to hospital staff or of unrestricted admitting privileges for any of the three named physicians not be provided to this department in a timely manner, this variance will no longer be valid.
