On March 2, 2012, the Department of State received your request for information pursuant to the Pennsylvania Right-to-Know Law, 65 P.S. §§ 67.101, et seq. (RTKL), wherein you asked for “everything in Alan Howard Molson's file (M.D.), License No. MD036412L including but not limited to his applications, renewal applications, complaints, lawsuits and disciplinary reports.”

Your request is granted in part and denied in part as follows.

- The records for which access is granted are enclosed. There is no fee due per the Department’s policy of not charging a fee if the copy cost is less than \$5.
- The printout from the License PA database shows there is no disciplinary history for this licensee. Assuming that such records exist, the Department has denied your request under § 67.708(b)(17) (non-criminal investigation).


