I was calling to see if you guys do abortions there. CLINIC: Yes, we do. CALLER: Do you know how much it cost? CLINIC: I sure do, honey. How far into the pregnancy are you? CALLER: I don't know. How do you know? CLINIC: Can you tell me the first day of your last normal period? CALLER: January 3rd.

CLINIC: If January 3rd is correct, about right now you're about almost nine weeks. The cost up to 12 weeks is between 300 and \$400. And the cost difference, it just matters what type of anesthesia you use and when you come in.

CALLER: Oh, okay.

CLINIC: Okay?

CALLER: The thing is I'm going to be 14 later on this month, and my friend said that you guys would have to tell my parents. But my boyfriend's 22. Is he old enough to take care of it, and you wouldn't have to tell anybody?

CLINIC: No, honey. No. You have to have a parent permission. You're 14 and he's 22?

CALLER: Well, I'm going to be 14 on the 23rd.

CLINIC: You're not 14 yet?

CALLER: Right.

CLINIC: Okay. You're 13 and he's 22 (laughing)?

CLINIC: This is the same thing you would hear from your parents.

CALLER: Well, they know we're going out. I mean, he works with my dad. They don't know that we're having sex. If they found out about that, I don't know what they would do.

CLINIC: Let me ask you a couple questions, okay? CALLER: Okay.

CLINIC: What would happen if you told your mom?

CALLER: I don't know. She would -- I don't know. They would just be furious.

CLINIC: Okay. What county do you live in?

CALLER: I live in Kent. I'm not really sure which county it is.

CLINIC: Okay. If you live in Kent, Ohio, you live in Portage County. I'm going to tell you what you can do to get around telling your parents. But I think in the long run it's always better if you can tell your parents. Even though you know they're going to get angry, honey, you're 13 years old.
