I, ALLEN S. PALMER, D.O., understand that my license to practice healing arts in the State of Missouri will be on, and subject to, the following probationary conditions:

- (A) This Agreement shall continue for five (5) years from this date;
- (B) I will provide, free of charge, medical services to the Obstetric-Gynecology Clinic at Normandy Hospital in St. Louis, Missouri, and for the Cuban Coalition under the auspices of the Archdiocese of St. Louis for not less than one hundred eighty (180) hours per year, devoting as nearly as possible four (4) hours per week for the duration of my probation; however, in the event either of these charitable endeavors cease, I will so advise the State Board of Registration for the Healing Arts (the "Board"). I will agree to perform other similar charitable work approved by the Board as a substitute therefor;
- (C) I will violate no laws of the State of Missouri or the United States of America, other than traffic related and similar offenses;
- (D) I will appear before the Board at such reasonable times as they may request and I agree to receive unannounced visits by investigators for the Board at my principal place of business;
- (E) The terms of my probation may be revoked at anytime if the Board, upon notice and hearing, concludes that I have violated any terms of this probation;

It is recognized that I have voluntarily entered into this Agreement in lieu of the formal procedure of surrendering my license to practice healing arts and having same immediately reissued and returned to me on the above stated conditions.
