Attached is a copy of the September 30, 1991 order of the Ingham County Circuit Court vacating both the August 3, 1990 order of the Board of Medicine revoking pr. Alexander's license and the November 2, 1990 order denying motion for reconsideration, and remanding the matter back to the Board for further proceedings concerning the sanction imposed on Dr. Alexander.

Judge Giddings stated on the record that Dr. Alexander should be afforded the opportunity to present mitigating evidence prior to the Board's imposition of a sanction. Judge Giddings did not upset the status quo, that being that Petitioner's license to practice is surrendered (you will recall it was surrendered while Dr. Alexander was incarcerated) and that he is not currently practicing medicine, and will not practice medicine until further order of the Board.
