FINAL ORDER GRANTING REINSTATEMENT

WHEREAS, on September 29, 1995, the Michigan Board of Medicine, hereafter Board, issued its Final Order Denying Reinstatement, in the matter of Robert L. Alexander, M.D., hereafter Petitioner; and

WHEREAS, on December 13, 1995, the Loard lesued its Final Order Granting.
Reconsideration and Rehearing, and

WHEREAS, a hearing was held before an administrative law judge who, on April 12, 1996, filed an Order Transmitting Transcript to the Board of Medicine, a copy of which is attached hereto; and

WHEREAS, the Board considered the within matter at a regularly scheduled meeting held in Lansing, Michigan on May 15, 1996; now, therefore

IT IS HEREBY ORDERED that Petitioner shall be and hereby is GRANTED a

Petitioner shall practice medicine only in a Board-approved structured training program, under the supervision of a Board-approved licensed physician.

Pelitioner may prescribe controlled substances only under the direct supervision of a Board-approved licensed physician in the structured training program.

IT IS FURTHER ORDERED that Petitioner's license shall be and hereby is placed on PROBATION, to run concurrent with the aforesaid limited license, subject to the following terms and conditions:

- Petitioner's Board-approved licensed supervising/training physician shall submit quarterly reports to the Board, as further provided herein, advising of Petitioner's work performance. In the event Petitioner, at any, time, falls to comply with minimal standards of acceptable practice or appears unable to practice with reasonable skill and safety, the Board shall be immediately so notified by said training/supervising physician.
- Petitioner shall seek and obtain the services of a Board-approved licensed psychiatrist who shall be provided a copy of this Order by Petitioner. The psychiatrist shall submit to the Board quarterly reports which address Petitioner's lithium levels and his mental and/or psychological ability to practice medicine in a safe and competent manner. If, at any time, the aforesaid psychiatrist finds that Petitioner, for whatever reason, is unable to safely practice medicine with reasonable skill and safety to the public, the Board shall be immediately notified by said psychiatrist.

IT IS FURTHER ORDERED that all reports required herein shall be filed on a quarterly basis, the first report to be filed three (3) months after the effective date of this order, c/o Compliance Section, Legal Resources Division, Bureau of Occupational and Professional Regulation, Michigan Department of Consumer and Industry Services, P.O. Box 30018, Lansing, Michigan 48909.

IT IS FURTHER ORDERED that the timely filing of all reports required herein shall be Retitioner's responsibility and the failure to file said reports within the time limitations herein provided shall be deemed a violation of an order of the Board.

IT IS FURTHER ORDERED that any violation of the Michigan Public Health Code, 1978 PA 368, as amended, by Petitioner during said period of probation shall be deemed a violation of probation and constitute grounds for further disciplinary action by the Board.

IT IS FURTHER ORDERED that all costs and expenses incurred in complying with the terms and conditions of this Order shall be borne solely by Petitioner.

IT IS FURTHER ORDERED that, in the event Petitioner wishes to apply for reclassification of the aforesaid limited license, application for reclassification shall be in accordance with sections 16245 and 16249 of the Public Health Code, supra, and the rules promulgated thereunder.

IT IS FURTHER ORDERED that Petitioner must take and successfully complete the SPEX examination before applying for reclassification of the aforesaid limited license.

IT IS FURTHER ORDERED that this Order shall be effective on the date signed by the Board's Chairperson or authorized representative as set forth below.
