ORDER FOR MENTAL EXAMINATION

WHEREAS, on or about March 9, 1994, Robert L. Alexander, M.D. (hereafter "PETITIONER"), filed with the Board of Medicine (hereafter "BOARD") a Petition for Reinstatement with supporting affidavits in accordance with the provisions of 1980 AACRS R338.986; and

WHEREAS, on or about March 29, 1994, the Attorney General submitted the People's Response to Application for Reinstatement along with a Request for Mental Examination; and

WHEREAS, oral argument was heard before an administrative law judge on May 13, 1994, concerning the Attorney General's Request and the administrative law judge granted the State's Request for Mental Examination in his Order Following Pretrial Conference, dated May 16, 1994; and

WHEREAS, the Attorney General then submitted to the BOARD a Request for Mental Examination Pursuant to Section 16247(2), dated September 29, 1994; and

WHEREAS, PETITIONER submitted his Response to Request for Mental Examination Pursuant to Section 16247(2), dated October 4, 1994; and

WHEREAS, the BOARD, having read the existing administrative record, considered the within matter at a regularly scheduled meeting held in Lansing, Michigan, on October 12, 1994, and at said meeting granted the State's request for mental examination pursuant to 1980 AACRS R338.986; now, therefore

IT IS HEREBY ORDERED that PETITIONER shall undergo a comprehensive mental examination to be performed by the following BOARD-approved psychiatric expert: Dr. Thomas Carli, M.D., University of Michigan, Department of Psychiatry - Riverview Building, 900 Wall Street, Ann Arbor, Michigan 48109; telephone (313) 764-0267.

IT IS FURTHER ORDERED that said mental examination shall be undertaken and completed within sixty (60) days of the effective date of this Order.

IT IS FURTHER ORDERED that the cost of said mental examination shall be the responsibility of the BOARD.

IT IS FURTHER ORDERED that this Order shall be effective on the date signed by the BOARD's chairperson or authorized representative as set forth below.
