Susie Baldwin, MD, MPH, is a preventive medicine/public health physician with a long history of work in women's health and reproductive rights, including serving as the Medical Director for CFHC's Clinical and Community Health Programs. Since 2005, she has partnered with the Coalition to Abolish Slavery and Trafficking (CAST), a Los Angeles based human rights organization, to provide care for survivors of human trafficking. She also works on anti-trafficking issues as a researcher and advocate.

Kristy Cho, MSW, has been working with the Coalition to Abolish Slavery and Trafficking (CAST) since 2012. At CAST, she provides case management services to victims of human trafficking and is developing a program to serve victims of domestic minor sex trafficking in the Los Angeles area. She graduated from the University of Southern California with a Masters of Social Work degree.

Rebecca Gudeman, JD, MPA, is a senior attorney with the National Center for Youth Law in Oakland, California where she directs the Adolescent Health Law program. She specializes in consent and confidentiality law and is a national expert on crossagency information sharing. She is the author of numerous publications on consent, confidentiality and child abuse reporting law and trains nationally on these issues. She has provided technical assistance to public and private youth serving agencies looking to develop better information sharing and privacy protocols.

Pratima Gupta, MD, MPH, has worked with Kaiser Permanente for six years with a focus on increasing access to family planning and educating medical students and residents on transgender care and global health. She holds faculty appointments at the University of California at San Francisco and is the volunteer medical director of St. James Infirmary, a free clinic for sex workers in San Francisco. She is currently serving on California Family Health Council's Board of Directors. She received her medical degree from Keck, University of Southern California and her Masters of Public Health degree from the University of California at Berkeley.



Denise Lewis, MSN, MS, NP, is a nurse practitioner and works as a Medical Specialist at California Family Health Council. She provides trainings in the field of reproductive health, family planning and sexually transmitted infections. She has taught for the San Francisco Community College District in the training of Paramedics and Emergency Medical Technicians. As a clinical auditor for the Federal Family Planning Title X grant, she provides guidance to participating agencies regarding quality assurance, grant compliance and clinical improvement.

Dannelle Pietersz, RN, MPH, has been a medical specialist at California Family Health Council since 2008. She has over 20 years experience working in various aspects of women's health. She worked as a women's health nurse practitioner for over 13 years at a Title X funded community health clinic where she also served on the best practices committee.
