She has since held multiple leadership including President of the Association of Professors of Gynecology and Obstetrics (APGO), President of the Council of University Chairs, Vice President of ACOG, and Chair of the international ethics committee for FIGO (International Federation of Gynecology and Obstetrics) as well as Chaired the WHO Cervical Cancer Control committee and the subcommittee on Cervical Cancer Control of FIGO. She was Chair of Departments at Penn State, Oregon Health Sciences University and Brown as well as Center Director for Womens Health and Surgeon in Chief overseeing faculty in both inpatient and outpatient, academic and community based practices. With

broad community and interdisciplinary medical community engagement she built a signature womens health center and programs at OHSU fostering innovations in interdisciplinary and collaborative practices. As a consultant to the ACOG, she designed and implemented the SCOPE (Safety Certification for Outpatient Practice Excellence) Program, the first safety certification program for ambulatory care in Obstetrics and Gynecology. She presently serves as the Chair of the Scientific Programme Committee for FIGO, the Chair of the Advisory Committee for HPV Vaccine Trials for the NCI, as well as continuing her work in medical ethics and womens cancers globally and expanding models for strategic planning, physician mentorship, engagement, and advancement in community and academic medical centers through her work at UMMS.
