I know you are in the process of scheduling a conference call for you, Jay and me to see if we can resolve this matter. Thank you for that. I just want to confirm, Dr. Kalo is scheduled to see ob-gyn patients tomorrow at his Southfield (Lathrup Village) office. He will not be performing any procedures. Although revocation of his freestanding surgical outpatient facility license may prevent him from performing more than 10 abortion procedures per month, it does not prevent him from seeing non-abortion related patients. He is a licensed physician and intends to conduct regular (non-abortion procedure) doctor's hours for which no license from LARA is required.

Thank you for your cooperation in resolving this matter as quickly as possible.
