CONSENT ORDER

The Virginia Board of Medicine and Sarah E. Forbes, M.D., as evidenced by their signatures affixed below, agree to enter into this Consent Order affecting the license of Dr.

Forbes to practice medicine and surgery in the Commonwealth of Virginia.

FINDINGS OF FACT

The Board adopts the following findings of fact in this matter:

1. Dr. Forbes was issued license number 0101-012203 by the Board to practice medicine and surgery in the Commonwealth of Virginia on July 20, 1954. Said license is currently active and will expire on May 31, 2012, unless renewed or otherwise restricted.

2. By Order entered January 6, 2010 *nunc pro tunc*, the license of Dr. Forbes was placed on indefinite probation and subject to certain terms and conditions. Dr. Forbes met all the terms and conditions of such Order with the exception of passing a clinical competency assessment by PMSCO Healthcare Consulting ("PMSCO").

- 3. In response to the assessment results, Dr. Forbes reports that she had a medical event during the testing, which resulted in the poor assessment results.
- 4. Prior to undertaking the PMSCO assessment, Dr. Forbes had announced her plans to retire from the practice of medicine. Subsequent to undertaking the PMSCO assessment, Dr. Forbes notified the Board in writing of her decision to retire from the practice

of medicine. Dr. Forbes has notified her patients of that decision and made a public announcement to that effect.

CONCLUSIONS OF LAW

This matter is properly before the Board.

CONSENT
