- 1. Plaintiff, DORIS JOHNSON, at all times relevant hereto is a resident of the City of Detroit, County of Wayne, State of Michigan.
- That Defendant, Henry Ford Hospital, was and is a Michigan Non-Profit Corporation duly organized and licensed and existing under the laws of the State of Michigan with its principal place of business in the City of Detroit, County of Wayne, State of Michigan and a branch medical center at

- 3. That Defendant, D. Freirichs, M. D., at all times material herein was a physician duly licensed to practice medicine in the State of Michigan and was employed by or had staff privileges at Defendant, Henry Ford Hospital.
 - 4. That Defendant, Terry Racey, PAC was at all times material herein a physician's assistant certified and licensed in the State of Michigan and was further employed by Defendant, Henry Ford Hospital, and was conducting physical examinations at Fairlane.
 - 5. That Defendant, Michael Hertz, M. D., at all times material herein was a physician duly licensed to practice medicine in the State of Michigan and was employed by or had staff privileges at Defendant, Henry Ford Hospital.
 - 6. That at all times material herein, Plaintiff was not given a choice as to who should perform emergency room and gynecological examination, and render medical care and treatment and procedures, such choice being that of Defendant Hospital and/or its medical personnel.
 - 7. That Plaintiff did rely upon the special medical knowledge of the Defendant Hospital, its emergency room facilities, gynecological departments and staff for the purpose of undergoing emergency medical care and treatment.
 - 8. That Defendant, Michael Hertz, M. D., and D. Freirichs, M. D. and T. Racey, PAC held themselves out to Plaintiff as specialists in the field of gynecology.

15. That on or about January 13, 1983, Plaintiff sought medical care and treatment from Henry Ford Hospital in Fairlane complaining of lower abdominal and pelvic pain and a
