It has been brought to our attention that the Transfer Agreement entered into between Capital Care Network of Toledo and The University of Toledo Medical Center, effective August 1, 2012, may expire on or about July 31, 2013. Rule 3701-83-19(E) of the Ohio Administrative Code requires the Ambulatory Surgical Facility to have a written transfer agreement with a hospital for the "transfer of patients in the event of medical complications, emergency situations, and for other needs as they arise."

In order to continue processing your pending renewal application, you must notify the Ohio Department of Health of the status of this transfer agreement. If the agreement is due to expire, you must provide a copy of another transfer agreement that will be effective on August 1, 2013 and thereafter and that also meets the requirements of rule 3701-83-19(E) of the Ohio Administrative Code. You must submit this information or your facility's plan for how it will comply with these requirements no later than 5:00 pm on **July 31, 2013**. You may submit this information:
