NARRATIVE AND ADDITIONAL INFORMATION:

About 9:21AM, Saturday 03/28/2015, Officer Tran and Recuperero in the K102D unit responded to a radio call for a person with a taser at 1055 Commonwealth Avenue (Planned Parenthood). On arrival, the officers was met by security officer [REDACTED] and she stated that a black male in the 20's wearing a grey hoodie and jeans walked through the metal detector with a taser. The security officer further stated that the electronic taser triggered the alarm when the suspect [REDACTED] walked through the detector. Suspect then removed the pink electronic Vipertek taser from his pocket and hand it over to the security officer, the taser was confiscated by securities and held for officers to arrive. Officers then spoke to the suspect inside the clinic's office and he stated that he woke up this morning to escort his girlfriend to clinic and didn't realize that the electronic taser was in his pocket. Suspect stated that he bought it online for \$10 on Amazon website and have no FID card. Officers informed the suspect that it's illegal to possessed the portable electronic weapon in Massachusetts. Officers activated the electronic device on and it produced a bright electric current pulsating between the test prongs and an electrical sound. The suspect was placed under arrest for illegal possession of an electronic portable device. Suspect was transported back to D14 and booked with no incident. The weapon was logged into evidence book page 159.
