COMPLAINT FIRST COUNT

Mary Ellon Daniel, Plaintiff, by Stuart Tay Robinson and Leonard A. Orman, her attorneys, hereby sues David O'Neil, M.D., Defendant, and states as follows:

- 1. On or about January 30, 1991, Plaintiff came under the care of Defendant, David O'Neil, M.D., who held himself out as duly qualified to render proper and adequate medical services.
- 2. When the said Plaintiff, Mary Ellon Daniel, came under the Defendant's care, it then and there became the duty of the said Defendant to exercise that degree of care and professional competence normally used by physicians when administering to patients.
- 3. Defendant treated Plaintiff at the above time and thereafter terminated her pregnancy status.
- 4. While Plaintiff was a patient of said Defendant, she was administered to by said Defendant, who, contrary to the accepted standards of medical care, failed to properly diagnose, the Plaintiff's condition, failed to properly administer to the Plaintiff, failed to take proper x-rays and sonograms, and failed to

properly read x-rays, performed surgery improperly, performed improper surgery, failed to give proper follow-up care and he was otherwise negligent and acting below the standard of care, including, but not limited to performing an incomplete therapeutic abortion, not removing all of the fetal tissue, disturbing the pregnancy enough to precipitate a pelvic infection, failed to properly utilize sonograms and other equipment and procedures and he was otherwise negligent.

5. As a result of the aforesaid negligence, carelessness, recklessness, imprudence and acting below the standard of care of the said Defendant, Plaintiff suffered and sustained great pain, shock, permanent injury, infection, required additional surgery, mental anguish, emotional pain and suffering, as well as medical expenses and loss of earning capacity.

WHEREFORE the Plaintiff brings this claim for damages in excess of TWENTY THOUSAND DOLLARS (\$20,000.00).

SECOND COUNT

- 7. Defendant failed to obtain the informed consent of Plaintiff prior to performing medical procedures on her in that he did fail to advise her of the extent of her condition and in that he failed to notify her of the extent of the necessary medical

procedure.

WHEREFORE the Plaintiff brings this claim for damages in excess of TWENTY THOUSAND DOLLARS (\$20,000.00).
