Low-income and minority women have greater difficulties than other women in avoiding unplanned pregnancy due to the disparities in access and affordability to critical preventive services. Making sure that contraceptives are affordable and accessible for economically vulnerable female-headed households with children and/or girls from economically vulnerable households is one of the best ways to help this high-risk group avoid unintended pregnancy. Sexual and reproductive health and delaying child-bearing are important components of a healthy life for women. They lead to
