Unless payment has already been made, payment in the amount of \$200 is now due from the Respondent as a result of the agency action. Such payment shall be made in full within 30 days of the rendition of this Final Order. The payment shall be made by check payable to Agency for Health Care Administration, and shall be mailed to the Agency for Health Care Administration, Attn. Revenue Management Unit, Office of Finance and Accounting, 2727 Mahan Drive, Fort Knox Building 2, Mail Stop 14, Tallahassee, FL 32308.



**NOTICE OF RIGHT TO JUDICIAL REVIEW**

REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA APPELLATE RULES. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF THE RENDITION OF THE ORDER TO BE REVIEWED.


**ORDER RELINQUISHING JURISDICTION
