Planned Parenthood Sex Education Team Program Blooms

Planned Parenthood of Houston and Southeast Texas, in collaboration with

AmeriCorps and Youth Advocates, created the Planned Parenthood Sex Education Team (PPHSet) Program. PPHSet educated six young men and women to become peer educators, so that they in turn can teach sexual health and responsibility issues to their contemporaries.

The AmeriCorps group developed a spirited one-hour presentation that uses rap, hip-hop, dancing and poetry to instruct young individuals about sexuality, relationships, diseases and the importance of abstinence.

During the fall of 2001, PPHSet performed for more than 1,000 teens at area schools. They also received standing ovations after performing for several hundred professionals at conferences held by the City of Houston Health Department and Communities In Schools - Houston.

The President's Corner

FINDING COMMON GROUND

As we look around the world and observe seemingly intractable conflicts, as in the Middle East, the Balkans, and Northern Ireland, we all yearn for a measure of peace and understanding. Perhaps the same could be said of the debates over sexuality, the role of women, and the options to address unintended pregnancies.

In the fall of 1999, thanks to the leadership of Christ Church Cathedral in downtown Houston, Planned Parenthood representing **Pro-Choice** met with **Pro Life** and **other community organizations**. The groups were drawn together to identify areas that we might agree upon. Three members represented each organization, and we met periodically for almost six months. (The groups mutually agreed to use the terms Pro-Choice and Pro-Life during the meetings.)

Initially there was an element of tension, but over time we were able to understand the values and beliefs that shaped our respective programs. Ultimately we were able to negotiate and agree on seven value statements whereby we found common ground. These statements were:

- While we may not agree as to when life begins, we believe that all human life is sacred.
- Every child deserves to be wanted, loved, and cared for.
- We believe that all people should have access to affordable, quality health care services and information.
- We believe that sexuality is a natural aspect of human life.
- We believe that there should be fewer unintended conceptions resulting in crisis pregnancies.
- We believe that, in pursuit of one's own point of view, the use of illegal violence against another person is never justified.
- We accept the sincerity of each other's beliefs.

As representatives of Planned Parenthood, we never compromised on our core organizational values and beliefs. Indeed, I feel this exercise strengthens our resolve to work towards healthy women, healthy families and healthy communities. I had hoped that we could share our work and end product with the media and wider community, but we could not reach consensus on a broader strategy.

I am sharing this with our supporters as I believe that being "Pro Choice" is being open to other opinions and respectful of all choices that women face when dealing with their sexuality and unintended pregnancies. We continue to believe that women have the moral capacity to make complex life decisions. And, we believe that women have the right to decide when, whether, and how to bring new life into this world.

We tried to keep our conversations from becoming debates, and I thought we were good role models for how these difficult issues could be addressed. Sometimes even a "cold" peace is better than no peace at all.

Free PAP Test Day a Success *By Cris Perez, V.P. of Communications & Marketing*



Once a year Planned Parenthood of Houston and Southeast Texas gives all women the opportunity to receive a free and possibly life-saving medical exam. On December 5, 2001, the fifth Free Pap Test Day was held in PPHSET's 10 clinics, and a record of 466 women were screened for cervical cancer that day. After their appointments, women were encouraged to write letters to their elected officials, asking for their support in funding women's preventive health care. In Texas alone, 1.5 million women do not have health insurance and cannot afford to pay for their annual health exams.

The American Cancer Society estimates that in 2001 there were about 12,900 new cases of cervical cancer in the United States. About 4,400 women have died from this disease.

According to the Centers for Disease Control, screenings for cervical cancer are lower among some disadvantaged groups, such as women with fewer years of educa-

tion, elderly women, and members of some racial and ethnic minority groups. Reasons for lower rates of screening include the lack of a regular medical provider, the lack of health insurance, and the lack of information about the importance of early cancer detection.

Cervical cancer forms gradually in the lining of the cervix, as cells begin to change from normal to pre-cancerous and then to cancer. This process can take a number of years, although sometimes it happens more quickly. For some women, pre-cancerous changes may go away without any treatment. More often, they need to be treated to keep their condition from becoming cancerous.

The Papanicolaou Test, or Pap Smear, is the most effective method for finding pre-cancerous changes or cancers on the cervix. To perform a Pap Test, a health professional takes a special sample of loose cells from the cervix. Examination of this sample under a microscope can help determine if abnormal

cells are present. The Pap Test provides the means to prevent nearly all deaths from cervical cancer.

Planned Parenthood of Houston and Southeast Texas has screened more than 1,600 women since 1997 through its Free Pap Test Day and plans to continue the annual program.

Voices for Planned Parenthood (VOX)

educates young people about the threats to reproductive health care and mobilizes them in support of reproductive freedom. VOX is part of the Planned Parenthood Responsible Choices Action Agenda, a proactive advocacy and service initiative to expand and secure reproductive rights into the next century.

In September, PPHSET hired two energetic interns to launch our VOX program in Houston. The interns will be organizing and mobilizing support for Planned Parenthood on the campuses of Rice University, University of Houston Central Campus and Texas Southern University. With a combined enrollment of over 40,000 students, these schools provide a large and diverse population in which to recruit future Planned Parenthood supporters.

PPHSET staff members from all departments, including public affairs, communications, education and volunteers, helped create and continue to manage the development of VOX to ensure that the program achieves its three main goals: to increase awareness of sexuality and reproductive health issues; to strengthen pro-choice, pro-

family planning leadership on area campuses; and to engage more young people as responsive advocates for Planned Parenthood and our issues. This inter-departmental approach to campus organizing allows all staff to take an active role in VOX and to provide the interns with the tools and information necessary to successfully engage students on these campuses.

Our VOX team has already participated in over 20 campus events reaching a total of 750 people! Of these students, 83 have signed up to become VOX members and hope to join our PPHSET family as volunteer educators.
