# STOPP INTERNATIONAL 2011 REPORT ON PLANNED PARENTHOOD CHIEF EXECUTIVE OFFICERS

By Robert Gasper and Jim Sedlak

American Life League's STOPP International project conducted research on the Chief Executive Officers of all the Planned Parenthood affiliates throughout the United States. The purpose of this research was to determine the salaries paid to the CEOs, their gender and their management backgrounds.

## Summary Results:

We identified 81 affiliates that are currently active. In examining the CEOs of these affiliates, we found:

- The sum of the total annual base salaries paid to PP CEOs is \$12,862,560
- Average salary of a CEO is \$158,797 per year
  - 22 (27%) make over \$200,000 per year
  - The dozen highest salaries were paid to CEOs of the following affiliates:

#### Background:

Planned Parenthood has a national headquarters in New York City. That headquarters organization, Planned Parenthood Federation of America, supervises the overall operation of Planned Parenthood in the United States. PPFA, itself, does not run any medical or educational facilities.

PPFA is made up of affiliates across the country. Each affiliate is an independently incorporated entity that voluntarily operates as part of the Federation. It must meet certain operational criteria and adhere to certain financial guidelines, including paying dues to PPFA, in order to use the name Planned Parenthood.

Our research shows that, in December 2011, PPFA was made up of some 81<sup>1</sup> affiliates. These affiliates had their own corporate offices in a total of 34 states. The affiliates operated medical facilities in 49 states (and the District of Columbia) and educational offices in an additional state (North Dakota). Each affiliate was led by a Chief Executive Officer appointed by that affiliate's Board of Directors.

#### Methodology:

The research was conducted using standard Open Source Analysis. All documentation was found using publicly available information. Sources included Federal Form 990s, Affiliate Annual Reports, Newspaper articles and other publicly available documents.

<sup>1</sup> Planned Parenthood lists three affiliates (Planned Parenthood of Central Ohio, Inc.; Planned Parenthood of Southeast Ohio; and Planned Parenthood of Northwest Ohio) all located at the same address in Columbus, Ohio and all with the same CEO. We counted these as one affiliate for this report.

## Planned Parenthood CEO Profiles

There were a number of choices to be made in how the data that follows could be presented. In the end, we felt that most people who used the report would be interested in the Planned Parenthood affiliates operating in a given state. Thus, the list is by state. In cases where a Planned Parenthood affiliate has operations in more than one state, we have included its full information under each state in which it operates. Although this means that the report has duplicate entries, it was felt that this would be most useful to the average reader.

*NOTE: The objective of this study is to compile open source biographical information of Planned Parenthood's CEO's. In order to remain as objective as possible, fair use direct quotations from media sources and even Planned Parenthood itself comprise the bulk of this report rather than summarizations. That being the case, the operations and actions of these CEO's at times are described in glowing or euphemistic terminology. American Life League in no way condones or supports the actions of Planned Parenthood and does not consider the operations of Planned Parenthood as "services" to the community.*

Planned Parenthood of Greater Iowa fought the subpoena in court, arguing that pregnancy test results were private medical records protected under state and federal law. In October 2002, officials withdrew their subpoena.

McGeown has always been a strong advocate for comprehensive sex education and continued to find ways to support an education department in spite of funding challenges. Franks, who is moving to Dallas with her husband this summer, has worked for the nonprofit agency for more than 12 years.

She began in 1998 as CEO of Planned Parenthood of Alaska. In 2005, she became president and CEO of Planned Parenthood of Central Washington. The agency merged with Planned Parenthood of the Inland Northwest in 2010 to form Planned Parenthood of Greater Washington and North Idaho.

The organization's board appointed Gage Stromberg, the vice chair, to head a search committee.
