Plaintiff, Christy T. O'Connell, by and through her attorneys, Emily C. Malarkey and Salsbury, Clements, Bekman, Marder & Adkins L.L.C., hereby moves pursuant to Federal Rule of Civil Procedure 4 and Maryland Rule 2-121(b) for the Court to approve Plaintiff's alternative service of process on Defendant Steven C. Brigham, M.D., and in support thereof, states as follows:

1. This cause of action for medical negligence sounding in diversity was initiated with the filing of a Complaint on April 21, 2014.

2. On August 14, 2015, Plaintiff filed a separate Complaint against Defendants Steven C. Brigham, M.D. and Vikram H. Kaji, M.D., arising out of the same facts as the original Complaint. That case was consolidated with the instant case on October 16, 2015 (ECF No. 49).

3. Dr. Brigham is a New Jersey resident, but he owns the Maryland abortion clinics at issue in this lawsuit. According to the New Jersey State Department of the Treasury, Division of Taxation, Dr. Brigham owns a residence located at 1094 Corbridge Court, Vorhees, New Jersey. *See* Exhibit 1-A.

4. As will be seen below, Plaintiff has been actively trying to serve Dr. Brigham for months without success. At this time, the involvement of the Court is requested.

5. According to Federal Rule of Civil Procedure 4, service may be effected by delivering the summons and the complaint to the Defendant, by leaving the summons and complaint at the Defendant's residence with a person "of suitable age and discretion who resides there," or by delivering the summons and complaint to an agent of the Defendant who is authorized to receive service of process. *See* Fed. R. Civ. P. 4(e)(2). The Rule also allows service of process by "following state law for serving a summons in an action brought in court of general jurisdiction in the state where the district court is located or where the service is made." Fed. R. Civ. P. 4(e)(1).

6. Maryland state law outlines the procedure for serving a Defendant who evades service of process. According to the Maryland Rules, "[w]hen proof is made by affidavit that a defendant has acted to evade service, the court may order that service be made by mailing a copy of the summons, complaint, and all other papers filed with it to the defendant at the defendant's last known residence and delivering a copy of each to a person of suitable age or discretion at the place of business of the defendant." Md. Rule § 2-121(b).

Plaintiff has attempted to serve Dr. Brigham multiple times and in several manners since August of 2015. In the fall of 2015, Plaintiff retained a private process server through Elliott Legal Support Services, LLC, located in Cherry Hill, New Jersey. That process server was unable to serve Dr. Brigham by any of the methods acceptable under Fed. R. Civ. Pro.

8. Plaintiff then retained Status, LLC, a second private service company in New Jersey. As is set forth in **Exhibit 1-B**, through that company, Plaintiff made the following attempts to serve Dr. Brigham:

- a. Tried to deliver the Writ of Summons, Civil Cover Sheet, Complaint, and Election for Jury Trial to Dr. Brigham's residence at 1094 Corbridge Ct., Voorhees, NJ 08043, on November 11, 2015. Dr. Brigham did not answer the door. Dr. Brigham's neighbor, who lives at #1095, stated that the man that occupies #1094 is rarely at home. The neighbor further stated that he had not seen the man for the last two weeks.
- b. Attempted to serve Dr. Brigham at his last known place of business in New Jersey, located at 1 Alpha Avenue, Suite 27, Voorhees, NJ 0843, on November 12, 2015. An employee of the neighboring suite stated that Dr. Brigham moved out six months earlier.
- c. Repeatedly tried to serve Dr. Brigham at his residence (Corbridge Court) on the 14th, 16th, 20th, and 27th of November 2015. There was no answer each time.
- d. Attempted once again to serve Dr. Brigham at his residence on December 2, 2015. Again, there was no answer. A contact card was left.
- e. Tried once more to serve Dr. Brigham at his residence on December 5, 2015.
  There was no answer at the door, but the contact card had been removed. *See*Exhibit 1-B (Affidavit of Jeffrey Tobin).

9. After Plaintiff was unsuccessful at effecting service in the usual manner under the Federal Rules, Plaintiff took steps to serve Dr. Brigham according to Rule § 2-121(b) of the

Maryland Rules. On December 16, 2015, through a process server, Plaintiff delivered the Writ of Summons, Civil Cover Sheet, Complaint, and Election for Jury Trial to Dr. Brigham's place of business at OB/GYN Care, LLC, located at 9801 Georgia Avenue, Suite 338, Silver Spring, MD 20902.<sup>1</sup> Dr. Brigham's medical assistant, who agreed to only identify herself by her initials, "D.B.," accepted the documents on behalf of Dr. Brigham. D.B. stated that she would fax Dr. Brigham the documents. *See* Exhibit 1-C (Affidavit of Kharii Brodie).

In accordance with Md. Rule 2-121(b), Plaintiff also left a copy of the aforementioned documents at Dr. Brigham's residence on December 19, 2015. *See* Exhibit 1-B. At the time, the bedroom light in the house was on, but there was no answer at the door. Plaintiff posted the documents on the front door of Dr. Brigham's residence and took a photograph of the posted documents. *Id.*

11. As set forth above, Plaintiff has made numerous attempts to serve Dr. Brigham under the usual methods outlined by the Federal Rules of Civil Procedure 4. Dr. Brigham has evaded service of process.

12. Plaintiff has also fulfilled the requirements for service of process described in Maryland Rule 2-121(b). Namely, Plaintiff has physically left a copy of the summons, complaint, and all other papers filed with it at Dr. Brigham's last known residence, and has delivered a copy to a person of suitable age or discretion ("D.B.") at Dr. Brigham's place of business. *See* Md. Rule 2-121(b).

12. As a result, and under Fed. R. Civ. Pro. 4 and Md. Rule 2-121, Plaintiff respectfully requests entry of an order to approve the alternative methods of service she has effected on Dr. Brigham, and to consider him served in this matter.

- 5. A copy of the Summons, Complaint, and related documents were posted on the door of Dr. Brigham's residential address on Corbridge Court in Vorhees, New Jersey on December 19, 2015 in accordance with Maryland Rule 2-121(b). See Exhibit B.
- 6. In further compliance with Maryland Rule 2-121(b), I served, via process server, a copy of the Summons, Complaint, and related documents on an associate of Dr. Brigham's at his Maryland business address in Silver Spring, Maryland. *See* Exhibit
  C. That individual, who would identify herself only as "D.B.," indicated that she knew Dr. Brigham and would fax him the documents.
- 7. As set forth above, Plaintiff has made many reasonable and diligent attempts at serving Dr. Brigham. The involvement of the Court is required at this time.
