Dear Doctor:

Pursuant to a random audit process, you have been selected to provide the continuing education documentation that you relied upon to complete your license renewal. Mailing, emailing and/or faxing a document does not guarantee that the information was received by the Kansas Board of Healing Arts. You will want to request a delivery confirmation to confirm your documents have been received by the Board. You may include your request for a delivery confirmation on the cover sheet of your fax or arrange a delivery confirmation through your postal service. All confirmations must come directly from the Board, or your parcel service. A fax machine transmission report will **not** be accepted as proof.
