Delhi Thweatt - Abortionist - Article One

Woman Died After Having An Abortion At HILLCREST Women's Medical Center

The following information comes from the \$2.5 million Civil Case: SCOTT B. MORSE v. DELHI THWEATT, MD. (No. 6070 S96) Dauphin County Court of Common Pleas. Rather than go to trial, on April 20, 1999, Dr. Thweatt and Hillcrest settled out of court.

On June 19, 1996, Kelly Morse had an abortion at Hillcrest Medical Center. The abortion was performed by Dr. Delhi Elmore Thweatt, Jr. Dr. Thweatt gave Morse the pain killer Lidocaine which she was allergic to. She immediately went into breathing difficulty and was unable to breathe. Morse turned blue-black in front of Dr. Thweatt and the Hillcrest staff. For 15 minutes, Dr. Thweatt literally just stood and watched Morse die. As Morse lay dying in Exam Room No.1, no one from Hillcrest called an ambulance for 10 minutes! When the EMTs arrived, Morse was brain dead from lack of oxygen!

The Case record found:

Hillcrest fraudulently advertised Dr. Thweatt as being a Board-certified Ob/Gyn!

"Defendant Thweatt failed the Ob/Gyn Board certification examination not once, not twice, but on three consecutive attempts...Defendant Thweatt failed his Board certification exam even after a fourth attempt, following his deposition of July 27, 1997."

Dr. Thweatt did not know how to properly administer a life saving drug.

"As Mrs. Morse's dyspnea and cyanosis (blackening of body due to lack of oxygen)

continued to worsen, Defendant Thweatt improperly administered Epinephrine subcutaneously instead of intravenously, this drug could not be absorbed due to Plaintiff's state of shock."

Dr. Thweatt literally did nothing as he watched Kelly Morse die!!!

"No one started an IV. No respiration rate was recorded, no pulse was checked and no blood pressure was measured. No EKG was applied. No cardiac monitoring was conducted. No pulse oximeter was applied. No intubation or emergency tracheotomy was performed. No oxygen was administered. Kelly continued to agitate in fear, desperately gasping for air, and remained blue in color. Defendant Thweatt just stood there with a stethoscope in hand and listened to Kelly's breathing and wheezing progressively worsen."

"As Plaintiff choked and gasped for air, none of the Defendants, took steps to immediately dispatch an ambulance. In fact, the ambulance was not summoned until 11:24 a.m., or 10 minutes after Plaintiff violently choked, gasped, wheezed, and discolored to a blue-black appearance from respiratory arrest and hypoxia."

After Dr. Thweatt failed the certification test four times, and after he failed to save the life of Kelly Morse, is he the best doctor for you? Why is Hillcrest still using Dr. Thweatt after the horrible death of Kelly Morse under his care?
