## **ASSENTED-TO MOTION TO EXTEND TIME**

- 2. 4. Defendant's counsel contacted Plaintiffs' counsel for assent to an extension and, based upon that discussion, the parties agreed that an extension to January 1, 2007 would accommodate both sides.

5. Granting this motion would not result in the continuance of any hearing, conference, or trial.

WHEREFORE, for the reasons stated herein, Defendant respectfully requests that the Court:

A. Grant this Assented-To Motion to Extend Time by extending Defendant's deadline to respond to Plaintiffs' objection and cross-motion for summary judgment to January 1, 2007.

B. Grant such other and further relief as is just and necessary.
