Affidavit of John Mauritz Hummasti

I, John M. Hummasti, being first duly sworn, hereby affirm and declare the following under the penalty of perjury:

- 1) I am the person making this affidavit.
- 2) I am of lawful age and competent to make this affidavit.
- 3) I make this affidavit based upon personal knowledge.
- 4) I have my permanent domicile in the State of Israel. On 22 August 2004 I formally applied for refugee status with the Israeli Ministry of Interior under the Israeli Law of Return. As a Jewish Refugee I abandoned my American Citizenship in favor of Israeli Citizenship. My file number with the Interior Ministry is 2 793/04. My permanent domicile is Selsian Market Rd. #26, Nazareth, Israel.
- 5) The cause of my abandonment of American citizenship was my having been persecuted by Muslims here in America; for example, when, in 2004, Amal Wahab, an employee of Multnomah County Health Department tried to extort money from myself and my wife and thus apply the Islamic (*shaaria*) Law of *dhimmi* and *al jizyah* as a form of protection in violation of the RICO laws.
- 6) I had previously renounced my American citizenship on or about 23 March 1994 and sent a formal declaration of such renunciation to the US Department of State and the British Consulate while simultaneously establishing the Commonwealth of Antarctica and acquiring International citizenship thereunder. My International passport number is OR57495-065USM.
- 7) As the Secretary of State for the Commonwealth of Antarctica I have proposed to UNESCO Amman, Jordan, the American Consulate and the State of Israel that the UN establish a regional International Human Rights Court in East Jerusalem for the purposes of combating terrorism and preventing

Human Rights abuses under my proposed, "Steps Towards Peace," which contains a comprehensive Statute defining and outlawing international and domestic terrorism.

- 8) Grace Bassem Hummasti is a natural born Israeli citizen. Her Israeli passport number is 9714939. Her Israeli Identity Card number is 58602277. Her permanent domicile is 407 Market St. #18, Nazareth, Israel.

I, John M. Hummasti, hereby affirm and declare under the penalty of perjury that the foregoing is true and correct to the best of my knoweldge.
