## **NOTICE UNDER IC 4-21.5-3-27(g)**

Hearing was held in this matter on September 24, 2015, after which the Board deliberated and reached a decision. Subsequently, the State submitted a Findings of Fact, Conclusions of Law and Final Order and then the Respondent also submitted a Findings of Fact, Conclusions of Law and Final Order. Each document reflected the submitter's proposal as to a written final order in this proceeding based on the Board's deliberations. The Board's first meeting after both documents had been submitted was on December 3, 2015. Four board members were present at that meeting including three who participated in the hearing in this matter and a new member attending his first meeting. The fourth Board member who participated in the hearing was not present.

Having considered the situation, the Board determined that the presence of all four Board members who participated in the hearing was appropriate to reach an appropriate final order. The Board's next meeting is on January 28, 2016, which is after the ninety day deadline provided for in Indiana Code 4-21.5-3-27(g). However, that statute allows the extension of the time period for various reasons one of which is "for good cause shown". The Board has determined that the circumstances described constitute good cause shown and therefore an extension for the issuance of the final order to February 5, 2016 is appropriate. Therefore, the Board's final order in this matter shall be issued on or before February 5, 2016.
