AAEME will have the NIRSAT available online 7/1/06. The test is open book and consists of 100 multiple choice and true/false questions. The test lasts four hours and the passing grade is 75%. The rater is notified immediately upon completion of the test of his/her grade.

Effective 9/1/06, only raters that have passed the NIRSAT will be assigned PPD evaluations pursuant to NRS 616C.490.





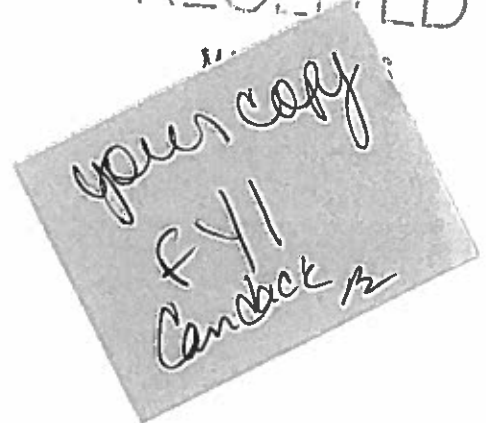

# Litigation left off HMO's '95 license application

The civil litigation pending against two officers of Silmo Healthcare Services Inc. didn't appear on the managed care company's 1995 license application, an insurance division financial analyst said this week.

Las Vegas Drs. Bob Molzen and Frank Silver are listed as officers and directors for the HMO, licensed September 1995 by the state Division of Insurance. A Clark County District Court jury recently found the doctors liable in an unrelated case for \$3.75 million on civil embezzlement charges; Silver said an appeal will be filed.

The HMO, as an independent corporation, will continue business as usual, Silver said.

"There's not a problem with the HMO," he said. "They don't relate in any way."

The insurance division's HMO application only asks about convictions, said Douglas Steiger, an insurance division financial analyst. Steiger said it "might be a good idea to broaden" the question to also ask about pending litigation.

"At the time, they hadn't been convicted of anything as of 1995," he said.

The lawsuit relates to the doctors' work at Red Rock

Urgent Medical Care. Dr. R.D. Prabhu, the majority owner in Red Rock, alleged the other physicians took away funds from the company while diverting patients to competing facilities.

Last week, a district judge boosted the \$3.75 million June jury award to nearly \$6.4 million, including interest and punitive damages.

Steiger couldn't say whether the lawsuit would affect the HMO's license until insurance division attorneys review the case.

David Carbon, the insurance division's chief financial examiner, said an investigation would be routine with any company whose founders were under legal scrutiny.

"It's a routine thing because part of our code deals with the ethics of the folks that we license," he said. "And this would fall in there."

Molzen was listed as the HMO's president and Silver as the secretary in a December 1995 financial statement submitted to the insurance division. Both physicians are the company's only listed directors.

As of June 30, the managed care company had enrolled 223 people, Steiger said. The company is one of a dozen HMOs licensed by the insurance division, he said.

# Medical company wins \$6 million

A medical company owned by prominent Las Vegas doctor R.D. Prabhu has been awarded more than \$6 million in a lawsuit brought against two Las Vegas physicians on civil embezzlement charges.

A district court jury found doctors Bob Molzen and Frank Silver liable for \$3.75 million to Red Rock Urgent Medical Care, whose majority owner is Prabhu, once a target of federal investigations but who now appears to have turned years of litigation to his favor.

District Judge John McGroarty last week entered an order adding interest and \$230,000 in punitive damages, bringing the total judgment stemming from the three-month civil trial to \$6,361,215.

"It was a vindication of his reputation," Prabhu attorney Randall Jones said Monday. "He hung on by his toenails for years. He would always say 'Open my books, you can see anything you want.'"

Silver attorney Eric Zubel promised an appeal, saying the jury's verdict appeared to be so confusing his client could wind

up benefitting financially.

Prabhu alleged the other physicians took funds away from the company while diverting patients to competing facilities. The lawsuit's core allegation was that Molzen, as administrator of Red Rock Urgent Medical Care, which owns the Red Rock Medical Center at 5701 W. Charleston Blvd., established a competing diagnostic clinic in the same building that treated personal injury victims.

The suit alleged many patients used Red Rock Urgent Care equipment and received medical treatment there, yet the billings

for the services were received by the competing clinic.

Prabhu contended he was misled as to the clinic's nature, that he was never told that Molzen and Silver were to be the owners of a competing facility and that he was informed the clinic would merely be a weight-loss program. He eventually fired both men, but Zubel said that did not affect Silver's minority partnership in the business.

A federal grand jury probe of Prabhu stalled in 1994 after grand jurors received all the evidence the government had in the case. A federal civil lawsuit

against Prabhu also raised accusations of violations of Medicare regulations involving tens of thousands of dollars.

But Jones said the civil lawsuit was withdrawn last year and that it began because of actions taken by Molzen shortly after Prabhu fired him. Prabhu's lawsuit alleged the two doctors, their company, Silmo Management Corp., and Molzen's wife, Starlene, embezzled funds between 1988 and 1990. Prabhu has also filed a defamation lawsuit in connection with the dispute, which has yet to be heard.

Zubel said because his client

owned 49 percent of the business, he would oddly enough seem to benefit by the judgment.

"The jury verdict was prepared in a way to make it easy to tar everybody with the same brush," Zubel said. "He (Silver) could not embezzle from himself. There is no evidence he ever got a dime from the Red Rock Diagnostic Center. He had a lease at the clinical center and Prabhu knew about the lease."

Molzen attorney Leland Lutfy could not be reached for comment.
