 - C. The term “maternal bloods” means blood samples taken from a pregnant woman.
 - D. The term “donor” means a person who has voluntarily consented to allow POC or maternal bloods to be used for scientific, medical, or research purposes.
2. **SERVICES STEM-EX PROVIDES:** Stem-Ex is a company devoted to providing services related to the procurement of human organs, tissues, and blood for medical research in order to facilitate medical research utilizing those tissues. Stem-Ex procures and ships POC and maternal bloods, preserves and processes POC, and provides infectious disease testing of donors.

This is the one we use to determine gestation, as well as the ultrasound report. I am so happy you were able to use the tissue and I hope the samples you were able to attach are successful. **DONATION OF ABORTED PREGNANCY TISSUE FOR MEDICAL
RESEARCH, EDUCATION, OR TREATMENT**

Recent advances in medical science have been developed through research using tissue that has been aborted. This research is being done to treat and find a cure for such diseases as diabetes, Parkinson's disease, Alzheimer's disease, cancer, and AIDS.

Tissue can be obtained as a result of donation of pregnancy tissue after an abortion. Before you give your consent to donate pregnancy tissue and/or a blood sample, **read each of the following statements and initial the line to the right.** If there is any statement you do not understand, or if you have any questions, someone will discuss them with you.

Before this consent was ever offered to me, I had previously decided to have an abortion and signed an informed consent document. _____

I agree to donate the tissue from the abortion and/or miscarriage, and a blood sample if needed, as a bodily gift to be used for education, research, treatment or the advancement of medical science. _____

I understand the donation is made without any restriction regarding who might receive the donated tissue or for what purpose it might be used. _____

I have not been informed of the identity of any individual who will receive the tissue that I am donating. _____

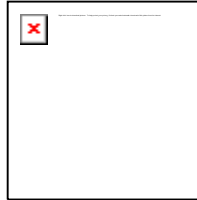
