# **Rochester, Minn. PP Quits Webcam Abortions!**

The Planned Parenthood (PP) facility in Rochester, Minn. has quit doing RU-486 abortions, referring abortion clients to its mega-abortion facility in St. Paul instead. Since late 2010, the Rochester PP had been killing unborn children via webcam abortions in which the pregnant woman would take the abortion pill (RU-486) after a long-distance internet conversation with an abortionist (presumably sitting in the St. Paul Planned Parenthood). The highest number of babies killed at the Rochester PP was 80 in 2013. From 2010 through 2015 (the latest year for which statistics are avail-

# We Were Outnumbered

On February 11 Pro-Life Action Ministries organized one of the more than 220 "Defund Planned Parenthood" rallies taking place throughout the country that day. We have a track record of having among the largest crowds at these nationally called for protests going back to the "Rallies for Religious Freedom" in 2012. A prime example was the more than 4,500 in attendance on August 22, 2015 after the undercover videos exposed the scandal of Planned Parenthood (PP) selling aborted babies' body parts.

On February 11, though, we were seriously outnumbered and there is much to learn from this experience. Before I get to those lessons, let me give you very clear information regarding our rally and the counter-protest.

First, the numbers. Whatever you may have heard or seen reported in the news media, the actual numbers were 450 of us to the PP supporters of about 2,500 to 3,000. Our numbers were among the largest in the nation, their numbers definitely were the largest in the nation.

Second, we were safe. The St. Paul Police Department (SPPD) did an excellent job of keeping order and peace. The two rallies were kept separate by a sixfoot zone created by barricades and closely monitored by the SPPD. We never had or felt a concern for safety at any time prior to, during or after the rally.

What happened? Our numbers were reduced because of a warning I believe needed to be made. In the week prior to the competing rallies, we learned that energy from the Minnesota "Women's March" (about 60,000 participants) a few weeks earlier was driving a large counter-protest of our rally. Knowing that some of those who would be counter-protesting would be vulgar, profane and obscene, I felt it my duty to warn parents of small children. And since most attendees of our events are

families, this warning may have more than cut in half our numbers (there were almost no children present at our rally).

Even had there been our original expected 1,000 to 1,200, we would still have been outnumbered. And this is where the lessons begin.

### Sidewalk Counselors Needed! Florida Supreme Court Rules in Favor of Kissimmee PP

Without surprise, the extremely liberal Florida Supreme Court on February 23 overturned two lower-court decisions which had temporarily blocked surgical abortions and sonograms from taking place, due to covenant restrictions in the medical complex Planned Parenthood Kissimmee had moved their mega killing center into, in 2014.

The high court stated that the trial judge had misstated facts and sent the case back to the lower courts for further

# Yet Another Lie from PP's CEO

You would think that after Cecile Richards, CEO of the Planned Parenthood Federation of America, was called out regarding the myth that her organization provides mammograms, the deception about prenatal care, and the "3%" statistic, that she would be more careful about what she says. But in a March 8 CNN interview with Anderson Cooper, she said, "We're here to serve women, provide them all the health care they need. That includes birth control and cancer screenings and safe and legal abortion access."

But in no way does PP provide women "all the health care they need." In mid-February, a pro-life investigative caller contacted Planned Parenthood of Minnesota, North Dakota, South Dakota (PPMNS) to make an appointment for an annual exam. After being told that this appointment would include a pelvic exam, a breast exam and a check of vital signs, the caller said she was in her late 50s and wanted an exam that includes blood work, etc., (a *real* annual exam).

The PP employee told her they don't do "primary care," they do "sexual, reproductive" health care. Then she gave her a phone number for United Way to obtain a referral for a clinic that does primary care. So much for "all the health care" a woman needs being provided by Planned Parenthood!



litigation.

Interestingly, PP had scoffed at the lower-court decision and only for a short time did they halt surgical abortions. They started committing them again within a matter of months. They never did stop offering chemical abortions; those always continued.

When plans were found out that PP was planning to move their mega-center into Kissimmee, large crowds of Christians turned out in great opposition to America's largest abortion provider moving into their area. City Commission meetings were packed out, with many doctors, nurses, businessmen and women, and citizens voicing their concerns and utter disdain at the thought of an abortion center coming into Kissimmee.

Unfortunately, these crowds have dwindled off, and with the news of the original lower-court decisions earlier, Christians somehow thought that ALL

## **CEO of Minnesota PP Second Highest Paid in Nation**

The CEO of Planned Parenthood of Minnesota, North Dakota, South Dakota (PPMNS), Sarah Stoesz, was compensated \$488,069 in 2014, making her the second highest paid PP affiliate CEO in the country (the CEO of the Pacific Southwest affiliate made \$500,972). This is from a new report by American Life League's STOPP International (2017 PP CEO Report, www.stopp.org). Stoesz's salary has steadily increased over the past few years, so one can assume that she makes even more now from an affiliate that kills about 5500 unborn children a year in its abortion mills in St. Paul and Sioux Falls, SD. Interestingly, in contrast to Stoesz's high-ranking salary, the income of the Minnesota affiliate was

20th in the country at \$18,888,507.

The average income of a CEO at one of PP's 56 affiliates is \$237,999, according to STOPP's report. This puts the average PP CEO in the top five percent of all workers in the U.S. Cecile Richards, CEO of the Planned Parenthood Federation of America (PPFA), made \$957,952 in 2015.

Brian Gibson, Executive Director of Pro-Life Action Ministries, commented, "I believe that these outrageously large salaries lend further credence to the fact that Planned Parenthood is not about providing services for the poor, but indeed are all about making a killing off the poor."

### Norma McCorvey of Roe v Wade Passes Away

Pro-life activist Norma McCorvey, 69, died February 18 at her assisted-living facility in Texas. She was known as "Jane Roe" in the U.S. Supreme Court's 1973 *Roe v. Wade* decision legalizing abortion.

Pro-abortion advocates used Norma to advance their efforts to legalize abortion in the early 1970s, She never had an abortion (her daughter was born and placed for adoption), but she became an icon in the national abortion debate and worked at an abortion mill in Dallas. While there, she was befriended by local pro-lifers and eventually underwent a conversion to Christ and the pro-life cause in the mid1990s. She then became an outspoken advocate for protecting the lives of mothers and their unborn children, speaking at pro-life events across the coun-



try, including the 1998 Pro-Life Action Ministries banquet.

National pro-abortion organizations were silent upon Norma's death. Apparently, her conversion was an embarrassment to them.

able), 320 babies lost their lives there.

"We are encouraged that the Lord has heard our many prayers and we are thankful that no more babies will die in this facility via RU-486," said Paula Ellefson, local pro-life leader and coordinator of 40 Days for Life in Rochester. "It is directly across the street from one of our city's high schools and it is typically very busy with students throughout the day."

According to the Minnesota Department of Health, the Rochester PP started doing abortions in November 2010, but this did not become public knowledge until a PP vice president, Connie Lewis, told the *Rochester Post Bulletin* in August 2011, "In recent months, we have begun providing a limited number of medicinal abortions at the Rochester clinic." Pro-lifers in Rochester have been sidewalk counseling and conducting rallies there ever since that article came out. Twelve 40 Days for Life Campaigns have been conducted there, along with several "Defund PP" rallies and MCCL (Minnesota Citizens Concerned for Life) events. Paula and her team of pro-life activists in Rochester will continue to pray that this PP will close down completely! And we are hopeful that fewer Rochester-area women will chose abortion with the end of abortions at this facility.

Minnesota was one of three states where webcam abortions were known to be committed. PP in Iowa pioneered webcam abortions starting in 2008 and PP in Maine started in 2016. With the end of abortions at the Rochester PP, webcam abortions are no longer being done in Minnesota.

with the evil spirits in the heavens." (Ephesians 6:12) We must be present regardless of who has the larger turnout. This is not the first time we have been outnumbered by a profane and obscene crowd. As an example, we conducted a prayer rally in Robbinsdale about 25 years ago. The practice of placing the names of abortionists in this newsletter has a twofold purpose: to ask for your heartfelt prayers for the conversion of those listed and to inform you so that you are not patients of those committing abortions.

The criteria for placing someone on this list is that the individual is directly almost 500. This crowd was far more vile, crude and profane than what we experienced on February 11. Despite having the words of our prayers and songs perverted to blaspheme God by many in that crowd, we did what we needed. Eventually, we started outnumbering those supporting abortion and have enjoyed a long period of the nation's largest prayer rallies and vigils.

Lesson 2: When we "win" a presidential election, our people let up, while the supporters of abortion become energized. Though they become even more

### **Does Your Doctor Prescribe Abortifacient Birth Control?**

Ask your doctor if he/she does abortions or refers for them, or prescribes abortifacients such as the Pill, Ortho Evra (the "patch"), Depo-Provera (the "shot"), Nuva-Ring, the "morning-after pill," implants, or the IUD. All these methods (and others) can cause very early abortions by thinning the lining of the uterus so that if breakthrough ovulation occurs (which is possible) and a new life is conceived, the young human being may not be able to attach to the uterine lining and therefore he or she dies. These methods can also be very dangerous, even deadly, to the woman. If you live in Minnesota and would like to go to a completely pro-life physician, we have a list of such doctors. Lesson 3: This is a glimpse of things to come if we truly threaten the status quo of *Roe v. Wade.* A clear, sober assessment of how things will play out in this country needs to be made if we move toward making abortion itself illegal again. Those who profit from abortion will stir up those who believe they are losing something they deserve and their numbers will grow even more.

Lesson 4: We must be courageous! Time and time again Jesus teaches us "fear is useless," "be not afraid," and "take courage." Well, this seems to be the time to learn what this means in our contemporary culture. We cannot and must not back away because they come out with large crowds. Our efforts must remain peaceful and prayerful. We must go out and proclaim the truth while offering the mercy and love of God to those who despise us. And we must defend the defenseless and speak for those who cannot speak for themselves. And what a great opportunity God has given us! The more that we encounter, the more opportunities we have to display Christian character in the face of adversity and speak with compassion to those who so seriously dislike us. All in the name of Jesus.

Last thoughts: Our prayer events these past decades have been largely attended by families with small children. And if you ever are concerned that your children will see and hear things you are not prepared to deal with or simply want to shield your children from, then please find others to watch your children and still attend yourself. There are always those in our churches and families who do not yet go out to these prayer events. Ask them to babysit, but attend yourself. And let us all pray as never before!
