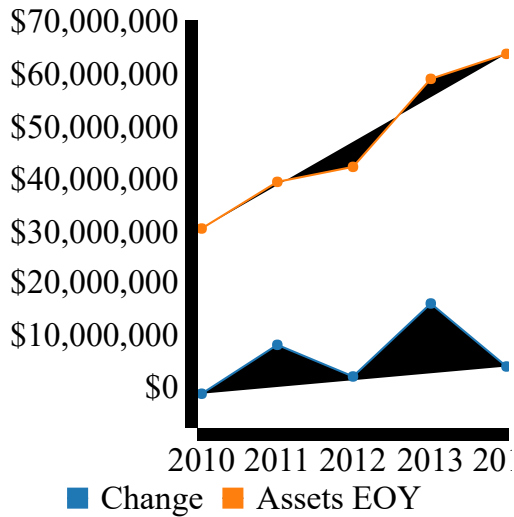
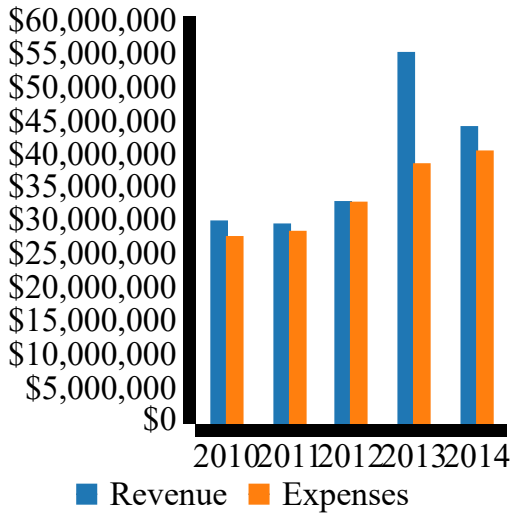
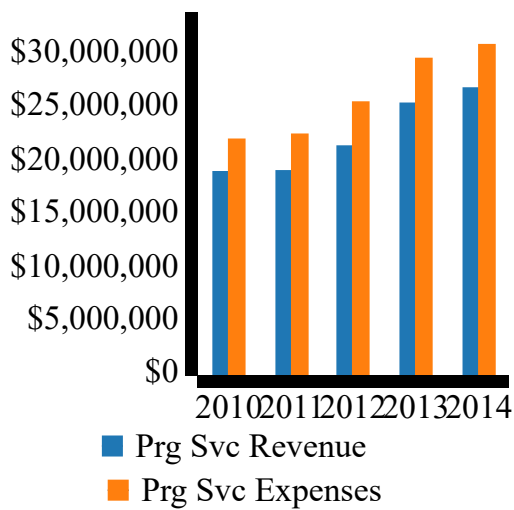

## Finances and Program Service Revenues

It had revenue of \$44,444,818.00 and expenses \$40,791,443.00 between January 2014 and December 2014 that year it had program service revenue of \$26,860,300.00 and program service expenses \$30,914,000.00 .



Planned Parenthood Minnesota North Dakota South Dakota started 2014 with \$59,713,525.00 in assets, and finished it with \$64,486,231.00

Revenue have exceeded expenses for all of the reporting periods. Program service expenses have exceeded program service revenue for all of the reporting periods. While total assets of have grown in some years, it also had shrunk in other years.
