

# President Trump's Pro-Life Record

During his first year in office, President Donald Trump has already proven to be the most pro-life president in history. First on the list of his pro-life accomplishments is keeping the extremely pro-abortion, pro-Planned Parenthood Hillary Clinton from winning the presidency.

Other pro-life accomplishments by the Trump administration include:

## MEXICO CITY POLICY

President Trump restored the "Mexico City Policy," which prevents tax funds from being given to organizations that

perform or promote abortion overseas. The policy was later expanded to include a broad range of health-related U.S. foreign aid and renamed Promoting Life in Global Health Assistance.

## UNFPA FUNDING

The Trump administration cut off funding for the United Nations Population Fund due to that agency's involvement in China's compulsory-abortion program.

## SUPREME COURT

President Trump appointed Neil Gorsuch to the United States Supreme

Court and is working closely with the Senate to fill vacancies in Federal and Appellate Courts.

## TITLE X

In 2016, the Obama Administration issued a regulation to prevent states from withholding Title X funds to providers deemed unsuitable, such as Planned Parenthood.

President Trump signed into law H. J. Res 43 to restore authority to states to direct Title X funds to providers they

### Is Your Doctor Involved in Abortions?

### Does Your Doctor Prescribe Abortifacient Birth Control?

Ask your doctor if he/she does abortions or refers for them, or prescribes abortifacients such as the Pill, Ortho Evra (the "patch"), Depo-Provera (the "shot"), Nuva-Ring, the "morning-after pill," implants, or the IUD. All these methods (and others) can cause very early abortions by thinning the lining of the uterus so that if breakthrough ovulation occurs (which is possible) and a new life is conceived, the young human being may not be able to attach to the uterine lining and therefore he or she dies.
