ORIGINAL PETITION AND REQUEST FOR DISCLOSURE

COMES NOW Robert Hanson, D.C., Plaintiff complains of J. Glenn Smith, D.C. Defendant and for cause of action shows:

1. Plaintiff intends to conduct discovery under Level 2 of Texas Rule of Civil Procedure 190.3 until the Court enters a level 3 scheduling order.
2. Plaintiff, Robert Hanson, D.C. is an individual and domiciles in Tarrant County, Texas. Defendant J. Glenn Smith, D.C. is an individual with a principal place of business at 9850 North Central Expressway, Suite 260, Dallas, Texas 75231.

4. Suit for Declaratory Relief

The Plaintiff sues for a declaration from the Court that he is the owner of the URL, www.coldlasertreatmentcenter.com and that Defendant J. Glenn Smith, D.C. does not have a right to that URL; and that Defendant shall cease and desist in demanding that Plaintiff turn over the URL to Defendant.

5. Jury Demand

Plaintiff demands a jury trial and tenders the appropriate fee with this petition.

6. Conditions Precedent

All conditions precedent to plaintiff's claim for relief have been performed or have occurred.

7. Request for Disclosure

Under Texas Rule of Civil Procedure 194, plaintiff requests that defendant disclose, within 50 days of the service of this request, the information or material described in Rule 194.2.


Prayer
