ARTICLES OF ACCEPTANCE UNDER  
GENERAL NOT-FOR-PROFIT CORPORATION ACT

To: Secretary of State, Jefferson City, Missouri

Be it known, that the undersigned corporation, for the purpose of accepting the provisions of "The General Not-For-Profit Corporation Act" of Missouri, and amending the Articles of Incorporation of the corporation so as to conform thereto, do hereby make and execute these Articles of Acceptance and certify as follows:

1. The name of this corporation is: PLANNED PARENTHOOD ASSOCIATION OF ST. LOUIS.

2. The following resolutions were duly adopted by the Board of Directors of the corporation at a meeting of said Board, duly held on the 1<sup>9</sup>th day of March, 1974.

RESOLVED, that this corporation does hereby accept all of the provisions of Chapter 355, R.S.Mo., and shall henceforth be deemed a corporation organized under the provisions of said chapter.

FURTHER RESOLVED, that for the purpose of amending the Articles of Incorporation of the corporation in the manner provided by "The General Not-For-Profit Corporation Act", said Articles of Incorporation of this corporation be and they are hereby amended so as to read in their entirety as follows:

ARTICLE I: The name of the corporation is THE PLANNED PARENTHOOD ASSOCIATION OF ST. LOUIS.

ARTICLE II: The period of duration of the corporation is perpetual.

ARTICLE III: The address of its registered office in the State of Missouri is 4947 Delmar, St. Louis, Missouri, 63108, and the names of its initial registered agent at said address is Betty Bilgere.

ARTICLE IV: The number of the Board of Directors shall be determined according to the by-laws of the corporation.

ARTICLE V: The incorporators are as follows:  
Mrs. James R. Higgins, 18 Willow Hill Road, St. Louis, Missouri, 63124; Mrs. William H. Laird, IV, 7632 Westmoreland, St. Louis, Missouri, 63105; Mr. William E. Drake, 3318 Laclede, St. Louis, Missouri, 63108.

ARTICLE VI: The objects and purposes for which this corporation is formed are as follows:

1. To promote an educational program and to work with all groups for improving family relationships and the health of mothers and children as basic to the social, mental and physical welfare of the public.

2. Under the direction of the medical profession to make sound, modern methods of contraception available to all persons.

3. No members or shareholders have voting rights.




