Synopsis: This investigation is predicated upon receipt of a complaint (Case summary Exhibit #1), from K.N.M., 35 y/o female, in regard to ROTH, alleging he provided substandard care; performed wrong/unauthorized procedure and failed to maintain records. Alleges K.N.M. presented to ROTH's clinic in Hollywood on 12/11/17, for an abortion pill procedure. Alleges K.N.M. signed consent forms for the procedure and was taken to another room. K.N.M. alleges she was injected in her arm and waking up later in a recovery room. Alleges a staff person informed K.N.M. ROTH had mistakenly performed a surgical abortion because her chart got mixed up with another patient and told her she had to sign new paperwork consenting to the surgical abortion before she could leave. Alleges K.N.M. requested her medical records several days later and was told the original consent forms she signed for the pill abortion had been 'accidently shredded.'

INVESTIGATIVE DETAILS

INVESTIGATOR'S NOTE: A telephone voice message was left for K.N.M. to call this Investigator on 03/21/18.

INTERVIEW OF K.N.M. (Source):

On 03/21/18, Investigator ROSENBLATT interviewed K.N.M. via telephone. The complaint was read and reviewed. K.N.M. stated she wrote a very detailed description of the events that took place at A Women's Center located in Hollywood, Florida. K.N.M. stated she made it very clear when she presented to A Women's Center she wanted to have the medical 'pill' abortion and signed all the related documents for the same. K.N.M. stated she was first lead into a room where her vitals were taken. K.N.M. stated the medical assistant also explained how to take the 'pills' and possible side-affects. K.N.M. stated she was taken to another room to do her blood type and she was advised an ultrasound would be taken to determine how far along she was and she was estimated to be 4-5 weeks pregnant. K.N.M. stated she was also told she may need a intravaginal ultrasound to see the fetus and was told to go to the bathroom and undress from the waist down. K.N.M. stated she gave her credit card and signed for \$450.00 for the medical abortion pill.

K.N.M. stated she was given a gown and booties to put on her feet and taken to another waiting room where another woman was sitting there with a gown on. K.N.M. stated she then went to another room for an ultrasound. K.N.M. stated there was another nurse or medical assistant in the room and she was told it was Dr. ROTH. K.N.M. stated she was mentally distraught, crying, and was told to get on the table, put her feet in stir-ups and open her legs. K.N.M. stated at no time did Dr. ROTH introduce himself or ever speak to her about what they were doing or look at her directly. K.N.M. she was urged again to put her feet in stir-ups and when she hesitated she could see the frustration in Dr. ROTH's eyes. K.N.M. stated the last thing she remembered, after looking up at the ultrasound as they put it equipment on her abdomen, she saw what appeared to be a small fetus and as she was crying someone put a needle in her right arm. K.N.M. stated when she woke up she was confused and felt drugged. K.N.M. stated a staff member helped her up and lead her into another room to sign more documents as she was told a surgical abortion has been done because there was a chart mix up. K.N.M. stated she had not consented to a surgical abortion, but was told she must sign the documents before she could leave. K.N.M. stated this was traumatic and she felt a violation of her body. K.N.M. stated there was no apology from Dr. ROTH.
