22 In accordance with this Court’s March 28, 2019 Under Advisement Ruling (“Ruling”),
23 the reasoning of which is incorporated herein by reference, and good cause appearing therefor:

24 IT IS ORDERED ENTERING JUDGMENT in favor of Defendant Planned Parenthood
25 Arizona, Inc. and against Plaintiff Mayra A. Rodriguez on Plaintiff’s claim for front pay
26 damages and back pay damages. As described in the Ruling, federal immigration law and

1 policy preempt any Arizona law that would otherwise permit Plaintiff to recover either front pay
2 damages or back pay damages on any of the claims alleged in her Complaint and serve as an
3 absolute bar to Plaintiff's ability to recover any such damages in this action.

4 IT IS FURTHER ORDERED, based upon Plaintiff's stipulation, that Plaintiff is not
5 entitled to and may not recover an award of her attorneys' fees, or any portion thereof, in this
6 action.
