**REQUEST FOR LICENSE
INACTIVATION WITH CAUSE AND
ORDER INACTIVATING LICENSE

7 1. I, Gabrielle J. Goodrick, M.D. ("Respondent"), am the holder of License No.
8 22811 to practice allopathic medicine in the State of Arizona.


9 2. I hereby request that, effective at 5:00 p.m. on the date of the following Order,
10 the Arizona Medical Board ("Board") inactivate with cause my license to practice
11 allopathic medicine number 22811. A.R.S. §32-1452(F). I participated in the Board's
12 Physician Health Program ("PHP") from December 21, 2010 through December 21, 2015.
13 I have now relapsed.

14 3. I will not practice medicine in Arizona or any other state, territory or district of the
15 United States or a foreign country while my Arizona license is inactive. I may not hold or
16 maintain a controlled substance certificate with the Drug Enforcement Administration or
17 write or refill prescriptions as long as my license is inactive. If I practice medicine while my
18 license is inactive I will be practicing medicine without a license and/or without being
19 exempt from licensure, which amongst other things, is a felony.

20 4. I shall not request reactivation of my license to practice medicine in Arizona until
21 I complete a long-term residential care or inpatient treatment program as required by
22 A.R.S. § 32-1452(F) and subsequently complete an assessment with the Board's PHP
23 Contractor and the Board is in receipt of the assessment findings and recommendations. I
24 understand that I may also be required to complete other evaluations if deemed

1 necessary by the Board. The Board will not reactivate my license until I present evidence
2 satisfactory to the Board, in its sole discretion, that I am medically competent and mentally
3 and physically able to safely practice medicine in the State of Arizona.

9 **FINDINGS OF FACT**

- 10 1. Respondent currently holds an active license to practice medicine in this state.
11 2. Respondent was under a Board stipulation or probationary order pursuant to
12 A.R.S. § 32-1452 that is no longer in effect.
13 3. The Board initiated case number MD-16-0607A after receiving a confidential
14 report that Respondent relapsed with the use of Fentanyl.
15 4. Subsequent to initiating the investigation, the Board received additional
16 information confirming that a relapse occurred on or about April 25, 2016.
17 5. Pursuant to A.R.S. § 32-1452(F), Respondent has requested that her license to
18 practice medicine in the State of Arizona be placed on the status of Inactive with Cause.

19 **CONCLUSION OF LAW**

- 20 1. The Board possesses jurisdiction over the subject matter hereof and over
21 Licensee.
22 2. The conduct and circumstances described above constitute unprofessional
23 conduct pursuant to A.R.S. §32-1401(27)(f) (“[h]abitual intemperance in the use of alcohol
24 or habitual substance abuse.”).

IT IS HEREBY ORDERED THAT:

- 1. License number 22811 held by Respondent is Inactivated with Cause.
- 2. Before Respondent can request that her license be reactivated, she shall successfully complete a long-term residential care or inpatient hospital treatment program or both and shall meet the applicable requirements of A.R.S. §32-1431(D).
- 3. Once Respondent has completed treatment, the Board shall determine if it should refer the matter for a formal hearing for the purpose of suspending or revoking the license or to place Respondent on probation for a minimum of five years with restrictions necessary to ensure public safety.
