I explained to Dr. Applegate over the telephone last week that at his September appearance, we can broach the subject with the Board and see if they would be willing to modify the frequency of personal appearances. Otherwise, the Board does not typically modify the terms of the Order for the first year following reinstatement.

As for the course requirements, there are courses available on the Board's website for the doctor's review. Sometimes the Association or the specialty boards can offer course suggestions as well. As with any of the courses, including the ones suggested on the Board's website, Dr. Applegate will need to submit a written request, along with the course syllabus.


