**06/11/2008: PROBATION COMPLETED: Doctor's request for release from the terms of the 6/14/06 and 5/14/08 Board Orders granted by Board vote on 6/11/08. Release from probation effective 6/17/08.**

**05/14/2008: BOARD ORDER: Upon reconsideration of Board's 6/14/06 Order pursuant to the 2/15/08 remand order from the Franklin County Court of Common Pleas, doctor's medical license suspended for one year from 6/16/06, which suspension has already been served; probationary terms, conditions, and limitations established for a period of at least one year from the 6/17/07 reinstatement of doctor's medical license. Based on the Board's determination that the 6/14/06 Board Order was appropriate in light of the 11/29/07 Opinion of the 10th District Court of Appeals. Order effective 6/3/08.**

**02/15/2008: COURT ACTION:** By Entry and Order filed 2/15/08, the Franklin County Court of Common Pleas remanded the matter to the Board for consideration of the appropriate sanction in light of the 11/29/07 decision of the 10th District Court of Appeals.

**11/30/2007: COURT ACTION:** By Opinion rendered 11/29/07 and Entry filed 11/30/07, the 10th District Court of Appeals affirmed in part and reversed in part the judgment of the Franklin County Court of Common Pleas, which had upheld the Board's 6/14/06 Board Order, and ordered the matter be remanded to the Board to determine the appropriate sanction.

**01/26/2007: COURT ACTION:** Notice of Appeal of the 1/16/07 Judgment Entry of the Franklin County Court of Common Pleas, which had affirmed the Board's 6/14/06 Order, filed with the 10th District Court of Appeals on or about 1/26/07.

**01/16/2007: COURT ACTION:**By Decision and Entry filed 1/16/07, the Franklin County Court of Common Pleas affirmed the Board's 6/14/06 Order, which Order suspended doctor's license for one year and established reinstatement conditions and subsequent probationary terms based on doctor's failure to provide complete and accurate information on Ohio licensure applications and prior actions against doctor's medical licenses by the Pennsylvania and New York boards.

**07/10/2006: COURT ACTION:**By Decision and Entry filed 7/10/06, the Franklin County Court of Common Pleas denied doctor's motion for stay of Board's 6/14/06 suspension Order pending the appeal in that court.

**06/28/2006: COURT ACTION:**Notice of Appeal of Board's 6/14/06 suspension Order filed by doctor with the Franklin County Court of Common Pleas on 6/28/06.

**06/14/2006: BOARD ORDER:** Medical license suspended for one year; subsequent probationary terms, conditions and limitations for at least one year established. Based on doctor's failure to provide complete and accurate information on applications for issuance and renewal of Ohio medical license pertaining to involvement in a professional liability action and action taken against doctor's clinical privileges by a Pittsburgh, PA, hospital; prior action against doctor's medical license by Pennsylvania's medical board based on doctor's prescribing controlled substances to doctor's spouse on eighty-six occasions without maintaining medical records; and prior action against doctor's medical license by New York's medical board based on the Pennsylvania board's action. Order mailed 6/16/06; Order effective 6/16/06; suspension effective 6/16/06 to 6/16/07; license returned to active status 6/17/07.

**08/10/2005: CITATION -** Based on doctor's alleged failure to provide complete and accurate information on applications for issuance and renewal of his Ohio medical license pertaining to his involvement in a professional liability action

**and action taken against his clinical privileges by a hospital in Pittsburgh, PA; prior action against doctor's medical license by Pennsylvania's medical board based on improper prescribing of controlled substances to his wife; and prior action against doctor's medical license by New York's medical board based on Pennsylvania board's action. Notice of opportunity for hearing mailed 8/11/05.**
