DEFENDANTS JANICE DUKE MD AND WRIGHT STATE PHYSICIANS' PRETRIAL STATEMENT

I. GENERAL CLAIMS AND DEFENSES OF THE PARTIES

Plaintiffs filed this obstetrical malpractice action against Janice Duke MD, her practice group Wright State Physicians ("WSP"), and Miami Valley Hospital ("MVH"); alleging malpractice in the management of Angela Williams's pregnancy in 2005. Azavier Preston was delivered by cesarean section on July 1, 2005.

Specifically Plaintiffs allege that Plaintiff Azavier Preston suffered a traumatic brain injury during pregnancy which would have been avoided by an earlier delivery.

Defendants deny all negligence and further assert that the alleged injuries suffered by Azavier Preston are unrelated to any ante mortem events.

II PROCEDURAL ISSUES

Trial is scheduled for October 5, 2015 for two weeks. However, the immunity status of Janice Duke MD remains pending and Dr. Duke has recently filed an *Assertion of Immunity* in this Court. As such, this Court is temporarily divested of subject matter jurisdiction over the malpractice claims until Dr. Duke's immunity status is resolved by the Court of Claims of Ohio.

In response to Dr. Duke's *Assertion of Immunity*, neither Plaintiffs, nor Miami Valley Hospital, has objected.
