## LOCAL TEENS TAKE TO THE CAPITOL

On Annual Capitol Day in April, more than 400 volunteers, staff and other supporters of Planned Parenthood rallied on the steps of the state Capitol to support legislation that is crucial to women’s health care rights.

This event was made possible thanks to our generous supporters. Teens, volunteers, staff, and others from all eight California affiliates visited dozens of legislators. They advocated for key bills that would allow women and their families to live healthy and productive lives.

One bill would help undocumented immigrants gain access to health care. Another would give financial help to mothers who are re-entering the workforce after they give birth. A third would eliminate a 10 percent reduction in reimbursement rates to Medi-Cal providers.

Planned Parenthood of the Pacific Southwest brought more than 60 people to the event that started at the Sacramento Convention Center. Advocates heard several speakers talk about the importance of supporting women’s health care rights. Then the group, dressed in hot-pink T-shirts, marched from the Convention Center to the Capitol steps several blocks away, waving banners and repeating chants in support of women’s health.

Speakers at the rally on the Capitol steps included Assembly Speaker Toni Atkins (D-San Diego), Sen. Ricardo Lara (D-Bell Gardens), Sen. Holly Mitchell (D-Los Angeles), and PPAC President and CEO Kathy Kneer. More than a dozen legislators, including Speaker John A. Pérez (D-Los Angeles), Mitchell and Atkins, donned pink ties, dresses and suits, and stood with Planned Parenthood at the rally.

## MESSAGE FROM THE BOARD CHAIR

The American poet Gwendolyn Brooks said, “We are each other’s harvest; we are each other’s business; we are each other’s magnitude and bond.” Here at Planned Parenthood we are living proof of this idea, with our strong partnerships that help strengthen our ability to serve the health care needs of our community. We are proud of our connections to schools, community groups, and faith organizations. It is gratifying to see how many people are deeply committed to social justice for all people.

In addition to providing high-quality health care, Planned Parenthood is also one of the nation’s primary sources of education about sexual health. We provide training for every teacher in the San Diego Unified School District who provides family life classes, which are offered to students in sixth, eighth, and tenth grades. We have similar relationships with many other school districts in our three-county region, and continue to grow our partnerships with schools and churches.

Planned Parenthood has close ties with the faith community. Recently, we worked with clergy to host a dialogue about community building and access to care. We are regularly invited to church-based health fairs to offer no-cost HIV testing and information about contraception and STD prevention, testing, and treatment.

We are very excited about a grant we received from The California Endowment that helps develop Latina leadership in the Coachella Valley. The young women selected for the program receive training on how to become effective peer educators and community advocates. This next generation of leaders has already visited the state Capitol to discuss legislative issues with elected representatives, and has participated in educational outreach efforts.

When Planned Parenthood works with other community organizations, we can better serve residents and help them live safe and healthy lives. We recently partnered with several organizations in Riverside to provide teens with self-defense and physical safety classes. At this event, teens were given the opportunity to ask our experts questions about sexual health.

Every day, Planned Parenthood works to make our region a safe and healthy place for all people. We are proud of our community partnerships that help make our work even more effective and meaningful. And of course, we are grateful to friends like you, who make all of our good work possible. Thank you for your continued support of Planned Parenthood.



## SO FRESH AND SO CLEAN!

As a part of the new **PLANNED PARENTHOOD EXPERIENCE** initiative, six health centers are currently being freshened up: Coachella, Sara Weddington Center College Avenue, El Cajon, Frances Torbert Center Euclid Avenue, Escondido, and Moreno Valley. Improvements like fresh paint, new flooring, updated furniture and artwork, window treatments, and appropriate signage have helped to spruce up the lobby and exam rooms while improving our patients’ overall experience. She has been a champion for reproductive justice throughout her career, beginning when she joined the staff of WomanCare Health Center in San Diego as director of clinic services. She helped expand clinical services by acquiring the Los Angeles Feminist Women's Health Center and opening WomanCare South Clinic in San Diego's South Bay.

As a San Diego City Councilmember, Atkins advocated on behalf of a residential picketing ordinance that prohibited the tactic of harassing abortion providers through aggressive picketing at their homes. She also sponsored council resolutions and commendations for Planned Parenthood and individuals who have demonstrated leadership in providing abortion rights and services.

We are so proud to see our local champion of choice representing Californians in Sacramento! Atkins has announced her leadership team and Assemblymember Manuel Pérez, another Planned Parenthood champion from our region, will be the next Assembly Majority Floor Leader. These two very powerful positions decide the fate of much of the legislation that comes out of Sacramento. Having two Planned Parenthood champions hold these key posts is a momentous occasion. 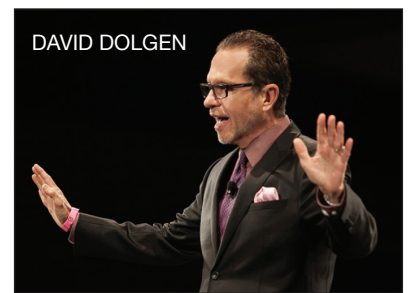

# STAFF BUILDS DREAM HEALTH CENTER IN A WEEK

3P, AS THIS EVENT WAS CALLED, IS A LEAN TOOL THAT STANDS FOR **PEOPLE, PROCESS, AND PREPARATION**. LEAN IS A PRODUCTION PRACTICE THAT MAXIMIZES CUSTOMER VALUE WHILE MINIMIZING WASTE.

What do one week, five pallets of cardboard, several very generous donors, and 30 staff with over 400 combined years of experience in the health care field equal? For Planned Parenthood, quite possibly the health center model for the future! In March, the agency organized a weeklong event that focused on designing a full-size prototype clinic for the affiliate to better serve patients and staff alike. At a single-story warehouse, staff designed their ideal health center using cardboard, complete with detailed room designs and equipment.

“The whole idea of this prototype is to keep things flexible,” says Project Manager Aline Racic. “With all of the changes that are coming up in health care, we need to make sure that we can accommodate those changes.”

Lean processes were aimed at achieving measurable results in patient care, efficient workflows, and higher satisfaction for both patients and staff.

The team hosted an open house for Planned Parenthood colleagues and other stakeholders to visit and provide feedback during that time. It was a great opportunity to share with them all the ideas and concepts the team is exploring.

The staff was instructed to dream big and throw any and all ideas into the mix. The resulting cardboard health center included insurance consultation areas, a large lab in the center of the space connected to each patient restroom, a “minute clinic” pharmacy with a Plan B vending machine and the provision of flu shots, frosted glass throughout the center to provide privacy between patient and staff-only areas, and a waterfall feature at the registration desk that patients see when they enter the health center. Now that a master floor plan layout has been created, the design team has information to develop interior drawings. The Planned Parenthood operations team understood the future improvements established during the week, and some features were determined to pilot now at select centers.

## BEYOND FOLLOW-UP

Our Case Management department was established in 2012 in order to help our patients navigate and access a full continuum of care within and beyond the scope of services offered at Planned Parenthood of the Pacific Southwest. In just a short time, the program has already increased the quality, efficiency, and cost-effectiveness of our patient care. These nurses listen, educate, and support each and every patient they speak with (more than 200 each day!). In fact, in October 2013, the Case Management team was awarded the 2013 Pioneer and Leader Award from the Planned Parenthood Federation of America Medical Services division, for demonstrating exemplary leadership in pioneering a new technology or strategy to advance the Planned Parenthood mission.

Stephanie Adamson, case management supervisor, had this to say about the program: "It is more than just the follow-up of labs or the triage and education of patients via telephone; on a daily basis staff assist with education on protocol and development of processes to improve productivity, and support Planned Parenthood staff and all clients to ensure the best health care service and experience. We maintain a positive outlook, which can be trying in health care... but people are more than numbers and we want every patient to know they are cared for and important to Planned Parenthood."

OUR CASE MANAGEMENT DEPARTMENT WAS ESTABLISHED IN 2012 IN ORDER TO HELP OUR PATIENTS NAVIGATE AND ACCESS A FULL CONTINUUM OF CARE WITHIN AND BEYOND THE SCOPE OF SERVICES OFFERED AT PLANNED PARENTHOOD OF THE PACIFIC SOUTHWEST.

A number of donors made critical investments early on, including the Price Family Charitable Fund, Dr. Harry Z. and Ruth M. Marx Foundation, Kaiser Permanente, and the Riverside Community Health Foundation. And more recently, thanks to a special partnership between the Susan G. Komen for the Cure San Diego Affiliate and two anonymous donors, Case Management has expanded to help our patients manage the complex area of breast health. Beyond financial support, Komen will also provide our patients with support group services and assistance with housing, food, and transportation.

## DIFFERENT WAYS TO SUPPORT PLANNED PARENTHOOD!

Thank you for making a gift to Planned Parenthood! We are so grateful for the gifts you make each year, each month, or when the mood strikes you. But do you wish you could do more to support an organization you care so much about? Here are some suggestions for non-cash giving alternatives that cost you little or nothing while you are alive, yet can provide substantial benefits to Planned Parenthood.

### BEQUEST.

This is the easiest way to make a gift to Planned Parenthood now that costs nothing during your lifetime. Consider naming Planned Parenthood in your will or living trust by designating a specific amount, or a share of the residue after making gifts to your family.

### LIFE INSURANCE.

Did you know you might have a gift hiding in the back of your desk drawer? Are you maintaining more life insurance than your family still needs? Consider donating a paid-up policy you no longer need, or make Planned Parenthood the beneficiary of your policy. Your donation will be exempt from federal estate taxes and you could receive a current income tax deduction for the paid-up policy.

### GIFT ANNUITIES.

These are simple contracts that provide lifetime payments to one or two persons. You can supplement your income with fixed payments that are partially tax-free and which remove taxable assets from your estate. Depending on your age, the rate you receive from a gift annuity might be significantly higher than stocks or CDs. You must be at least 70 to establish a gift annuity with Planned Parenthood.

And don't forget that you can always give **appreciated stocks** to avoid a tax on capital gains! You will receive an immediate income tax deduction for the full value of the securities.
