And if you want to get out of there fast – there is always the *"Fast-track & Privacy service,"* which is described this way, *"Our most economical VIP abortion service for NYC. For an extra fee we accelerate your appointment to minimize waiting time. This allows you to move through your procedure and have you in the comfort of your own home as soon as possible."*

I had a similar experience as other reviewers. When I called, I asked ""Do you take my insurance?"". I think this question implies ""Are you in network?"" I was told that they do take it (Blue Cross/Blue Shield) and I set up an appt. What they don't tell you is that they ""take"" or ""bill"" all insurances.... as out-of-network providers. They are only in-network for Medicaid, and maybe GHI...
